

## Cancer: Is it Really Incurable? A Review

### Abstract

The outcome of cancer surgeries has improved over the last 30 years or so. However, the probability of the cancer emerging after surgeries, has always been there. This was our main objective. Why does cancer return after it has been removed, allegedly totally, from a patient? This is a horrific thought especially for mastectomy patients, with the trauma and the helplessness, that they feel! Upon using the vibration herbal technique, in examining the patients, we discovered that viral cancer, in all probabilities, comes in clusters of CVS'S, that are activated in any sequence, and that determines, the type of cancer, the size of cancer and the treatment type. We were able to identify the structure of such cancers as breast cancer, colon cancer, pancreatic cancer, and even liver cancer, to name a few. It also appears that medical science may have not been able to identify these CVS'S, and therefore, are stumbling in making specific chemotherapy cures for each one of these CVS'S or groups of CVS'S as a whole. It also appeared that chemotherapy, in essence, is a means to eliminate these CVS'S. However, it also appears that chemotherapy treatments are for specific CVS'S, and may not work if used on a different CVS. Since cancer does not progress or is not initiated by a specific CVS at any instance, generalization of a specific protocol of treatment may not really apply. As an instance, there are four grades of type I breast cancer (in our classification), only one has triple negative CVS in the structure. To totally eliminate any viral cancer, all of the CVS'S in the cluster have to be eliminated, so as not to reappear. The treatment of pathological cancers, such as lung cancer, and stomach cancer, to name a couple, using the vibration method, we need to design three different cures one for each of the energies of the cancer. One design to eliminate "Q", CHI, a second to eliminate YIN (yn), and a third to eliminate YANG (yg). This may eliminate the cancer in its entirety.

### Introduction

1. Ever since medical history began to be recorded, mysterious ailments befall humanity.

History records, in every period, one or more, of these ailments come in form of epidemics. These were not being treated, as medical science, in many instances, was not able to understand the causes of such ailments. If, in any period, humanity were able to understand the cause of a disease, a cure or cures, were sure to follow.

Rapid progress has been made in medical research, in the last few years, especially in the so-called incurable diseases. However, it appears that the results of such research does not seem to keep pace with the amount of expenditure in those research experiments. It still appears that the causes of such ailments seem to be a mystery to the researchers doing the research. It appears that research is directed

towards the results of these ailments, other than the cause. One specific instance which I had to deal with, was Parkinson's disease. It is caused by a specific virus, as investigated by vibrational medicine, and once eliminated, the effects of the ailment on the patient, stops. It does not regenerate or return to original state, but rather stops deterioration. We will not dwell on this particular ailment; one manuscript dealt with it [16,18].

2. My original objective for this vibrational research was solely based on finding a cure for Hep. C Viral. That started in 1995. The most important objective was to determine what are the parameters of this Hep C virus that had baffled the world. That was no easy task; but was accomplished in 2015, just around 20 years later. We made a vibrational herbal cure for all six types of Hep.C genotypes, the relationship among them, and most importantly, how to define any virus, identify it, find its power, size and how to eliminate it in the shortest possible time. We conducted a clinical trial on many patients in the prestigious Egyptian Institute, Tropical Medicine Research Institute, in the year 2001.

3. It may have been unfortunate, or fortunate, depending on your point of view; that The Egyptian Health Ministry, or anyone associated with it, arranged a deal between a large foreign pharmaceutical company, which worked in research to find a chemical cure for the infamous Hep.C. Virus that plagued the Egyptian Populace for many years, and was not being treated correctly, as very little research was made in Egypt, to find such a cure, except for personalized efforts of some individual, such as myself, who deemed it a personal mission. It appeared that the pharmaceutical company would conduct its clinical trials of this new chemical treatment for Hep.C, on volunteer patients of Hep.C, for free, as payment for this free medication.

4. This was around 2015 - 2016, and we had arrived at juncture point where we had many of the variables of the Hep.C virus under control. We approached the ministry of health twice, via official channels, to allow us to try our safe, herbal treatment, but the unconventional approach we had, using herbs, and vibrations, obscured the true benefits of the treatment we had. The ministry officials were totally unresponsive to our suggestion, they had a chemical treatment, from a large, reputable foreign pharmaceutical company, giving free medicine, to try on unsuspected Egyptian patients, with a deadly disease, Hep c. Viral. To us, many things did not add up. The medication was prescribed, to all patients, in a specific procedure, regardless of the stage of maturity of the disease.

5. The important discovery, from our research for twenty years became apparent. Viruses can be easily deciphered not by modern science techniques, but using a simpler more uniform approach as described by our research over the previous twenty years. A virus is composed of two main parts, the replicating part, the part that regenerates itself and maintains the characteristics of the ailment represented by the virus, it also represents the power of the virus: it is always denoted by a power of 10 to the power of from 90 to 2000. The other main component is the size of the virus: how many replicating parts in the virus? is 100,000 or 1,000,000 or 2,700,00 units? Each virus has to be identified by itself, to determine its total parameters. As a vivid example, the Hep.C virus as described by this method, and taking genotype six, as an example, is 990,000 X 10 to the power 1080 CVS's.

6. That was a fascinating discovery, but how does it apply to the rest of the viral diseases in the world? It always was very intriguing to me, even as a young graduate student, as to why cancers do not seem to disappear with surgery. That they needed chemotherapy, radiation and other treatments, even after the drastic mutilating surgeries that were undertaken. A close colleague of mine contracted liver cancer. He was being treated in London, UK, in the best medical teams, and our medical insurance was the best and covered any procedures. That did not help and he passed away in agony. My question, that this is the UK, best hospital, probably the best doctors, but what about the medication? Was it really the best or the most effective? According to the attending personnel, that was the best treatments and according to the best and latest protocol. So why did it not work? I believe in destiny. I also believe that human beings always have a say, large or small, in their destiny. My analysis, is that something is wrong with the cure. Over the previous fifty years, I had seen close friends, relatives and family, succumb to different sorts of cancer, in various ways, after chemotherapy, after mutilating surgeries, after crippling doses of

radiation and Cobalt treatments, but that, usually, and eventually, the results were almost was finally death. This was the natural order of things, maybe? Is there no way that the outcome would be changed, any percentage of triumph over death, even for a short healthy life, free of cancer?

7. Inevitably, my alternative medicine technique, that I was developing into various fields of medicine to treat whatever medical science could not deal with, led some people with cancer to come my way. As I was mainly dealing with liver ailments, I dealt with some liver cancer patients. My approach was what caused this ailment, and what is its origin? Viral? Whether it is connected to Hep.C, or not, and how? That took several years to unravel, and resolve that problem with other issues along the way.

8. My work became a last resort to some people who could not find satisfactory solutions to their health issues. Were it a cure for Hep.C viral, different types of cancer, or even stiff necks. Diabetes occupied a large chunk of studies, experimented on different kinds of treatments, but no cure presented itself in the early days. We had some minor successes in curing Hep.C viral patients, albeit haphazardly, as we could not tie the cure to all patients cured. That was quite a resounding success in itself. These results prodded us on, something is working well, but what would that be?

9. The first case of breast cancer was introduced to us, by a lady who wanted her friend to be checked. She had mastectomy several months previously, but cancer was beginning to appear in lymph nodes and other places. The time was around 2001. Interestingly enough, my first survey of the patient revealed an active virus in her cancer. At that time, my first inclination was of the presence of viruses, otherwise, the cancer would have disappeared. Based on my knowledge with other ailments, I determined, as best as I could, the characteristics of that virus. We also tried to find a vibrational cure to eliminate that particular virus. Having a rudimentary knowledge of the CVS discovered, we went on to design a treatment to eliminate the energies of that CVS. The treatment was made and tried on the specimen of the patient. The reaction was good and the energies of the CVS were being eliminated. The duration of the treatment was 20 days, after which an x-ray was to be made, and was required to assess the effectiveness of the medication. Our assessment was that a large percentage of that CVS was eliminated, about 90%, so it definitely would appear in the X-ray. Although the patient felt better, the tumor did not disappear or grew smaller. We discovered a new CVS that appeared with the old one. There was a new CVS, and the tumor was still there. We eliminated one CVS, to have another one appear! It was starting to appear that breast cancer is a conglomeration of CVSs, that had to be eliminated to have the cancer actually and totally eliminated.

At that time, every time we eliminated one CVS, another one appeared in its place! How many are they? Are they all the same or having the same function: propagate cancer tumors and kill people? Our first conclusion was that in all probability, there are more than one CVS in the cancer group. Are they related, can they be accumulated together to form a treatment to help with this pervasive ailment? It was becoming clear that more than one virus is involved. Although oncologists may have been wondering, why breast cancer was not being eliminated, it may appear that none were of the opinion that maybe something called viruses may be responsible for cancer, its formation or propagation, and even if they did, how was it identified?

10. We were involved several times in separate occasions to treat post mastectomy appearance of cancer, which we did as best as we could, and we became convinced that CVS'S are involved, and to cure cancer, in various types, we have to resolve that question first. It had to wait for personal evolution and understanding of autoimmune disease (as described by medical science) and our interpretation of that description. It depended on our new understanding of clusters of CVS'S, and how they act and react towards cures.

11. Our main pressing problem was that of finding a cure for the infamous viral hepatitis C. With the passage of time, between 1992 and sometime in 2004, many strides were made towards finding a treatment or treatments, for Hep. C Viral. We were able to cure several Hep C patients, but could not combine the treatments as a cure for the six genotypes of Hep C. Our attention was directed towards any ailment that needed a cure. One such an ailment was HIV. It appeared from the literature that it may be a virus. So, what kind of virus? We were

able to obtain the specimens (photographs) of some patients and went on to analyze what type of virus afflicted each one? The other point is to try to determine if we can design a cure to eliminate each one of those CVS's. With our rudimentary knowledge of what viruses were, we struggled to find any treatment that eliminated any part of any of these viruses. We succeeded in several but failed to get one or more to work with one or more of the viruses, together.

12. Around 2006-7, a magic word was mentioned: "Autoimmune disease". It indicated that HIV, diabetes several other unknown diseases were being labeled as auto immune diseases? My work with HIV indicated that there are more than one CVS in the patients studied with HIV. Could autoimmune mean that there is more than one virus in that particular disease? I discovered three CVS'S in HIV, more than five in diabetes, this is a new type of disease category? Could that also work with breast cancer, maybe other cancers as well?

13. My main emphasis was a cure for Hep. C Viral, and we were making positive strides in that direction, several patients were totally treated, became Hep. C free, which was unheard of, we had a clinical trial with a prestigious lab associated with the Faculty of Medicine in Cairo University. However, the universal cure alluded us. However, each trial of a new treatment to eliminate the virus, drew us closer to the knowledge of the structure of viruses and the unravelling of its secrets. Two main diseases intrigued us. HIV, as an enigma baffling scientists all over the world and diabetes, the everlasting disease. Both have been labeled as "autoimmune diseases". That's a start for us. Can we lump together CVS's causing the same disease, and form a collective treatment, eliminating all CVS'S together in one treatment and several doses?

### What are clusters?

A- As our research took different turns over the years, whether we were working on HIV or trying to figure out the structure of liver cancer, what about lupus? And all the various types of diseases that modern science seemed to be churning out, daily, with little explanation, or just that they are probably autoimmune diseases. Luckily, I had categorized viruses, and autoimmune diseases based on the concept of energy as practiced by the Ancient Egyptians [1,6,7].

B- I was beginning to realize that the causes of some diseases may be different from the description or explanation being given by the research authorities responsible. Not to misinform or deceive the general public, but, in all probabilities, they seemed to adhere to ancient theories still being propagated, unwittingly. According to my latest discoveries, concerning viruses and autoimmune diseases, these have more to do with ailments than is generally attributed to them. Either medical science has not been able to get over the scientific absurdities of the 1800's, or they have but seem to hide it quite well to prevent the production of actual, effective cures other than the nonconclusive medicines that they seem to be producing. The mention of the word "cluster," started being swirled in my mind, when various CVS'S started to appear whenever a CVS was eliminated, in any so called auto immune disease, or a breast cancer diagnosis, that apparently shouldn't have more than one or two CVS'S, at the most, but were now running, three or four, until we stop, CVS's that really shouldn't be there, but are! Is it the misunderstanding of the researcher or the practitioner, who is trying to fit what the researcher has explained to him?

C- Our understanding of certain ailments did not usually fit with the description these ailments were being described in medical science or in the medical literature. Some cases, such as one mastectomy patient, who was having a relapse, even after following the so-called protocol, sent from overseas, where the Gods of technology and advancement reside. But regrettably, the young patient having been subjected to a multi layered concentration of chemotherapy, to reduce whatever remained of the cancer, that should have been removed with the lymph nodes and other parts that were deemed possible cancer sites, did not seem to be improving. I we are asked by a friend to check the patient, using those ancient techniques that seemed to create magical effects, as some were saying, but just applying solid scientific rules laid down by our own scientists many years ago. The patient had an infection of cancer in her breast. Our analysis indicated that two CVS'S causing some of the cancer have been eliminated, most probably by chemotherapy, which was continuing, but with little

progress. The cancer present was from a third CVS that was active and needed to be eliminated. The dose of chemotherapy being given, although according to the so-called protocol, was not effective, at that time. We determined the parameters of the active CVS, its power, size and the formula to totally eliminate it. We started the dosage to eliminate the cancer, and our results indicated the partial elimination of the cancer as exhibited by a great reduction in its four energy levels. The tumor markers indicated a lower value, confirming our results. However, on rechecking the patient, a new CVS appeared to be active, and not the same one we were medicating. We now have four different CVS'S that have revealed themselves as responsible for that cancer, until that point. A point of reflection: are these all the CVS'S, or are there more? Science did not mention anything about numbers, or what types were these?

D- That was the point which directed our attention to the fact that there may be several CVSs in any cancer, we have been dealing with two or three breast cancer cases, in various stages, and each one seemed to have some new cancers appear, even after chemotherapy and our intervention with treatments of those specific CVS's that we believe cause the cancers. The question being formulated was, how many CVS'S are in each cancer type? Are they different? Are there different types of cancer that may express a larger number of CVS's? Can we generalize, that viral cancers contain more than one causing cancer CVS's? Many of these questions were answered in the following couple of years, due to circumstances and pure luck. Four different breast cancer cases presented themselves, only one had mastectomy, but were having cancer reappear, others were just discovering the presence of lumps in the breast, the beginning nightmare to any woman! The fear and trauma of breast cancer with women is truly frightening, and to eliminate any element of that equation is usually blissful. The treatments I offered, was an alternative to this nightmare, and gave women hope of a better outcome.

E- In the year 2023, four patients of breast cancer presented themselves to be treated. They all appeared within about three weeks of one another. Each one was checked. One had a mastectomy and some lumps were beginning to form. She was being given chemotherapy, but came on the hope that our treatment will end her nightmare. The other three, each was having some lumps, and were under scrutiny. Two were prescribed chemotherapy, and the third was not settled on her course of action. For each, and based on our procedure at that time, we identified what we thought was the cause of the active cancer cells. There were four different CVS's that were identified. Their energies were different, and each cure did not react with the other patients. That, to us, meant that there are four different CVS's, did that mean there are four different kinds of breast cancer, or maybe something else? All four CVS'S were similar in the fact that they were all composed of four negative energies, the normal characteristics of a CVS in our description of a CVS.

F- However, a fifth patient, who had a mastectomy several years before, aged around 78 years old, was beginning to have fears of developing breast cancer again. We were asked to check her condition, as she was wary of having a surgeon decide her fate. The initial check indicated a CVS that was active. However, to our amazement, that CVS did not conform to the known characteristics of having four negative energies describing it, but only three energies, with the Yang component was zero, it was not there. There were only three negative energies. This was a totally unexpected development. That CVS did not react to any cure that we had for other CVS'S, even old cures did not react. It needed a totally new treatment to eliminate it. That was a new challenge to us. We analyzed the characteristics of the new CVS, and finally came up with a treatment that eliminated the energies of that virus, in about 28 days, taking two capsules daily after lunch. The patient was presented the treatment, and after 28 days, she was free of the energies of that CVS. It is also interesting to note that, unlike other patients, no new CVS appeared. We have now identified a new CVS in breast cancer which is a triple negative type.

G- Back to the four patients with breast cancer. We started treating each one using the treatment designed for each one. Each treatment was usually for 25 to 28 days of after lunch capsules, to eliminate the specific CVS. All the results were promising, the energies of the CVS'S were decreasing, the patients felt well and were experiencing new high spirits. What became a common denominator was the fact that the resulting X-rays and tests on those patients, were not in line with our findings. They did not seem to be improving. It became clear that more CVS'S keep appearing even when the ones we were treating were being eliminated. It should be logical, in a world of logic, that some of these treatments would be interchangeable, but in many instances, that was not the case. We have discovered that there may be more than one CVS causing breast cancer specifically, some patients exhibited three or less different CVS'S, and sometimes we had not reached

all the CVS'S that maybe present. It appeared that there maybe several different types of breast cancer, the cancers appear to be varied, and did not follow the same path in treatments.

H- Breast cancer was beginning to appear like an unsolvable puzzle, to us! A new patient was presented to us and we decided not to accept that challenge. There were various parts that we could not tie together in breast cancer. We had to accept to treat her, but explained that we may not be able to resolve this case, as we did not have good results, until now, with breast cancer. I pleaded with the patient to go see her surgeon. She refused, and insisted to try my treatments come what may. There was one active CVS, checked, analyzed and made a cure for her. After 25 days, the cancer energies were decreasing, but her tests were not improving. A new CVS appeared, a treatment was made and she started taking it. Again, I insisted that she see her surgeon, as my efforts did not appear to be working. She developed some complications, regrettably, while it was too late to be saved.

We stopped working with breast cancer patients, until we solved the puzzle of that cancer. If it is a disease, it can be cured! A new patient presented himself, he had excruciating pains in his left leg and in his leg bones, to the extent that he couldn't walk or even stand up straight! His medical prognosis was an inflammation in bone legs. We decided to examine him, if we could alleviate that pain, somehow. The diagnosis was slightly off. The man vibrations were those of cancer. On further study, the cancer was bone cancer. The preliminary check revealed that there are 3 active CVS'S causing the cancer at the same time. They appeared to be clustered together. We made our examination of each of the CVS'S, determined one mixture to treat all three. They had similar characteristics, so they could be lumped together in one treatment. The treatment was made and it reacted well with the patient, and eliminated the three CVS'S in 20 days, with 4, 900 mg capsules of the treatment taken after lunch daily. We followed the results of his check up daily, and the cancer energies were decreasing regularly. After about a week of treatment, two things happened, a- Most of the pain the patient felt, decreased considerably in just a few days, and b- On checking the patient, we discovered 3 new CVS'S, becoming activated in the cancer. We have now six different CVS'S that have been identified, and forming a kind of cluster of CVS'S causing the cancer. Researching bone cancer, there were many different kinds, but all, were composed of a cluster of CVS'S. Each type of bone cancer had its unique number of CVS'S in its cluster. Our count of these CVS'S ranged from six CVS'S to 12 CVS'S, for the largest type of bone cancer. We rechecked our patient, who had been under treatment for about eight days, feeling much better, eliminated at least 60% of the three original CVS'S energies, but had to change the treatment to include all the CVS'S in the cluster. The new treatment was designed to eliminate all CVS'S in that type of cancer [21].

I- It appears that we have discovered the concept of clusters in defining cancer tumors. Now, we want to test these findings. We return to breast cancer patients.

A friend introduced a patient who lives in Zagreb, and was diagnosed with Breast Cancer. My alternative method was mentioned, and I received the documents of the patient on my phone. Her diagnosis in the documents sent were as follows:

C50 malignant neoplasm of the breast.

Metastasis to the right axillary lymph nodes.

Core biopsy performed.

Oncological examination 12.8.2024.

In the case of the patient, a pathologically altered lymph node anterior axillary line on the right side was confirmed with triple-negative immunophenotype. She will be presented at the MDT (Multidisciplinary team for breast cancer), today, 12.8.2024, to discuss further diagnostic procedures.

B-Our examination of the specimen of the patient revealed that she had breast cancer, but it was caused by two active CVS'S that we identified. It was also revealed that the cancer has not spread, and that no triple negative CVS's were present. There was no need for hormonal therapy, it was not warranted. Our examination revealed that the breast cancer can be eliminated and the two lumps would disappear, using the anti-viral treatment designed for her. In our check on the treatment, no new CVS's appeared, nor any triple negative types (TN). Quite fortunately, our mutual friend, was flying off to Europe, where she could send the medication to Zagreb. The patient received the medication four days after my exam. The treatment was to take four, 900 mg capsules, for 30 days, all capsules after lunch, or any one meal, once a day. Our procedure is to follow the results of the medicine on the energies of CVS'S, to see how the medicine is eliminating the CVS's. If the cancer energies decrease, then the medication is working. We checked daily, and the decrease in the power of the cancer was prominent. The percentage of the cancer being eliminated increased daily, until after about 28 days, the energies of the cancer was totally eliminated. The interesting phenomenon is that, unlike previous trials with other patients, no new CVSS appeared, and all the lumps had disappeared. About ten days earlier. Another excellent indication to us, was the lack of the existence of any cancer vibrations in her body. Simply put, cancer has a certain vibration that it emits, if present, which lend credence to the fact that some dogs are trained to smell such vibrations. Our patient was being told by her doctors that she had to continue with the remaining protocol for the treatment of cancer prescribed. We insisted that she was totally free and had no fictitious TN type CVS'S. Chemotherapy, in essence, is supposed to try to eliminate what causes the cancer. However, cancers are different, and the ingredients of a particular chemotherapy treatment may not work with another similar patient. It took several weeks for the patient to prove to the oncologists that she was free of cancer, and would not take any more medication. However, a lump was discovered under her arm-pit. Bad news for the patient, great news for the Oncologists. Our examination of the lump, indicated that it was not cancerous, but some fatty tissues. It was removed; to find it was some fatty matter, non-cancerous. She had to get her own test made and be seen by a private Oncologist, to confirm that she was cancer free, and the Hospital to admit that!

C-The experience of that breast cancer patient, prompted a friend of hers, in Serbia, having the same problem to request my intervention. This patient already had surgery, removed parts of the breast, but started feeling lumps in her breast. Again, the same protocol was being applied. Our examination revealed her case was different from her friend. She had a cluster of CVS'S, but in this case, it was six CVS'S. It was larger than the first patient, but the characteristics of CVS'S were clear. However, although they mentioned TN types being present, we could not find any traces of any. It appeared to us from the protocols, that it is generalized to include any type or form of breast cancer as the oncologist did not seem to differentiate among the different types, even if they could decide on that. The treatment for the new type of cluster was designed, mixed and tried on the energies of the cancer. In this case, because of the distance between us, we included an additional cure, for TN types, if the need arises. This was a new treatment, that encompasses all six CVS'S, and it was more effective, we are able to control the power of the treatment and reduce the length of the treatment. The dose was four, 900mg capsules, once a day, preferably after lunch, for 30 days. The treatment for TN would be two capsules a day, once daily if need arises. In the period of treatment, the CVS'S were totally eliminated, and we didn't need to take the TN treatment.

This patient asked my help to treat her nephew, from rom some non-cancerous tumors in the Brain. Our examination discovered a cluster of four CVS'S, that were not cancerous, (No cancer vibrations), and was curable. The treatment was made and sent to her, but something happened and the treatment was confiscated at customs, in Serbia.

#### E-Colon cancer

1. Colon cancer is another type of cancers that we tried to treat about three years ago. We had three patients whose choices were limited, and we presented a chance for them to get well or even be cured. Each was examined, at that time we were looking for CVS'S causing the cancer. It was the same repetitive tale once again. A CVS is discovered, defined, a cure is made, the patient takes the cure, we see a great change in the energy characteristics of the cancer, but a new CVS appears, and we start the process all over

again. Something was wrong. We stopped trying with colon cancer patients, until late last year and early this year when we started thinking along the terms of clusters, and things changed.

2-a-A new patient, an older male patient, of about 76 years of age, was diagnosed with colon cancer. My examination revealed that he had six lumps on his colon, and it also revealed that the cause was the activation of three CVS'S, in a cluster. We started checking the presence of a cluster, and three CVS's appeared. We checked them out, they all had the same power, but were of different volumes. We were able to design a treatment, to eliminate the energy characteristics of the cluster. The treatment had a large base to encompass the three CVS'S in its action. The virtual trial test on the treatment and the patient, indicated that it will take 27 days of four capsules of the treatment after lunch, daily to eliminate all three CVS's, and it will eliminate the lumps in about eight days. The patient agreed to take the treatment accordingly, and it was prepared and given him to take. Our job was to monitor the progression of the treatment, and how well it was reacting to the cancer, and how well was the patient tolerating it. Five days into the treatment, two lumps had disappeared from the previous number, the patient was feeling "great" and the Cancer energies were decreasing steadily.

2-b-However, three new CVS'S appeared after the administration of the treatment. This was expected! The CVS'S had the same power as the first three, but were different in size. A new treatment mixture was designed, virtually tried on the new status, it worked quite well. The new treatment was made, to eliminate all six CVS'S, and was slightly more powerful to terminate the cancer energies quickly. We informed the patient and gave him the new treatment. We monitored the progress of the new treatment, and after a few days no new CVS'S appeared. We started to see the CVS'S one by one, be eliminated, until our checking did not reveal the presence of any cancer. However, the patient still had a few days to go. We informed him of the situation, and asked that he continue to until all the medication is finished. After that, he was requested to have a test to show if any tumor markers were discovered on his body. The tumor markers test indicated there were no tumors anywhere in the body. His oncologist was totally amazed, and cancelled a scheduled surgery on the colon. The patient was totally incredulous, and decided to perform a mini-pilgrimage to "The Holy City of Mecca", giving thanks to almighty God for delivering him from cancer.

2-c-This confirmed and helped us to confirm, the concept of clusters in our pursuit of viral cancer, it became another testament to the presence of clusters in viral cancer.

#### **IV-Non-viral cancers**

1-These are the cancers that do not appear to be caused by viruses. Lung cancer, for one.

The energy of the disease in a patient determines the energy of the cancer. The treatment has to eliminate all energies emanating from the cancer. The main energies are Q, Yn and Yg. To eliminate them we have to design one treatment (mixture) per energy. Therefore, we had to design three different treatments for that Cancer.

2-Stomach cancer, is a second cancer that needs three treatments. One for each energy group of the cancer.

#### **V-Results**

1-Over the years of research in treatment of various cancers, we discovered the difficulty of curing cancer due to many different reasons. One may have been the actual discovery of the causes of that particular cancer. Researchers appeared to view the results of the cancer on the patient, maybe because the cause of the cancer was difficult to discover. However, ever since we started using the new approach, of "vibrational herbal medicine" based on the "laws of ancient wisdom", which we detailed in our publication [1]. Our original quest was to identify a cure of Hepatitis C Viral, which was rampant in Egypt, in the 1980's, and had dire consequences on Egypt.

2-Over the years of research, around twenty years, we were able to identify a scheme of the design of any virus. There is a sequence to follow to determine all characteristics of any virus. It involved some esoteric work, but became a natural phenomenon. It sets the stage for anyone in the current medical research endeavors, to try and express this in language that maybe understood by all. Finding a cure for that Virus is a totally different task.

3-Our discovery of CVS'S, and our ability to eliminate them, helped in discovering the concept of Clusters of CVS'S. That discovery helped in finding treatments of such clusters. It is seldom that a cancer has only one CVS, but usually more. This is what we labeled as clusters.

4-Looking back at our research over the last thirty years, it is safe to determine that all viral Cancers come in clusters. Breast Cancer, as an example, is not one type, but three types. a- Type one: Consists of four different Cancers: a- Two CVS'S,

b- Four, CVS'S

C- Six CVS'

d- Six CVS's plus 3 triple negative CVS'S.

b- Type two: Consists of two CVS's.

None of the type one medication works on type two.

c- Type three: Consists of one CVS, unique in its characteristics.

It is interesting to note, that the whole treatment for type One, maybe taken, without having cancer, to act as a preventive vaccine for type One. This is an observation, not confirmed.

5-Bone cancer: Has a maximum of 12 CVS'S depending on where it strikes [21].

This is covered in details in publication [21].

6-Colon cancer

It contains a maximum of twelve CVS'S, but maybe less, depending on many factors, which were not our focus of study. There are different intensities, one type with six CVS'S, another with 9 CVS'S and a third one with 12 CVS'S. This may have three triple negative types. Our one patient, whom we diagnosed with Colon Cancer, was given the treatment to cure 9CVS'S that comprised his cancer. He was totally free in about 27 doses of 4, 900 mg of the cure, taken daily.

He was tested and declared free from any cancer vibrations.

#### **V-Conclusion:**

a- Based on our trials and experiments, we have discovered that several viral cancers are comprised of "cluster" of CVS'S that comprise the cancer.

b-Every cancer, will contain one cluster, containing a specific number of CVS'S, that determines the progression of the cancer. Until now, as an example, the approach is to label any breast cancer, as having triple negative CVS'S, difficult to cure, needs chemotherapy, new types produced by various pharma companies, that may or may not react with the specific CVS's that cause that particular cancer.

c-Our course of action is to determine what type of cancer in the breast, determine how many CVS's each cluster has, determine the treatment to eliminate such CVS'S, without surgery, and deliver the medication. This may be done before any surgery or chemotherapy. We have determined, many years ago, that chemotherapy is used to eliminate CVS'S without knowing, until now, which chemotherapy for which CVS'S. We could determine which chemotherapy to be used to eliminate a part of the cancer or not!

d-This procedure has been tried and used, for various types of viral cancer, and has been quite successful. The difficulty lies in the determination of the number of CVS'S in a cluster, because it will depend on true determination of the characteristics of the CVS'S.

e-It took us about twenty-five Years of research and practice, to be able to organize a scheme for the determination of the power of viruses, their size and the procedure to eliminate them. The scheme is very systematic, and quite orderly. However, this needs an expertise, and understanding, in the principles of vibrational medicine.

f-Non-viral cancers, such as lung cancer, need to eliminate each energy emitted by the cancer, in the patient. One for the CHI, "Q" component, one for the Yin (Yn), component and a third for the Yang component (Yg).
