

The Treatment of the New Corona Virus

Abstract

The new corona virus is a new virus which is part of the corona virus group of which the cold virus is one. It appears to have appeared in a new mutated form which may be transmitted from animal to humans. To vibrational Herbal practitioners, this is similar in some ways to the Sars virus, for which we designed a cure several years ago.

This virus is composed of three strains, all may lead to respiratory failure, if not treated properly. The treatment is composed of two 900 mg/capsule of the herbal mixture twice per 24 hour period. There is third dose which should be on stand -by, if, in rare cases, a third dose is required.

Several years ago, we studied the epidemic at that time, which was the "SARS" virus. Our studies led to herbal cure for the virus, but regrettably, we were not taken seriously. We gave that research and some sample cures to the Chinese government at that time, but they did not respond at all. Our studies indicated a complete cure of the SARS virus in two doses, of 1800 mg capsules each, for each patient.

We have continued on the same track and have come up with some very interesting data. Some of the published data have mentioned that the new corona virus may be related to some form of reptile or animal. Some findings on the characteristics of the strains:

- In the first strain, symptoms appear six days after infection. Pneumonia will appear two days later. Respiratory failure may occur after 10 days of infection. Using Chinese terminology, Wind Type people have a better immunity against this strain, while Earth type people are more vulnerable to its effects.
- In the second strain, symptoms start to appear seven days after infection, and pneumonia ensues on the eighth day of infection.
 Respiratory failure may start to occur on the 12th day after infection. People who are of the Fire sign are more resilient to this type, while Water types are more vulnerable to it.
- The third strain is the weakest of the three, in the sense that it takes longer for the symptoms to appear, whether it is more or less deadly, is unknown. Pneumonia may develop nine days after infection, while respiratory failure may occur after 14 days of infection. Fire type people may be more resilient but all other types may be vulnerable.

Treatment

In Vibrational Herbal Medicine (VHM), the investigation into the treatment entails discovering the type of virus, its size, the strains or genotypes, its characteristic energy code and how it changes when infecting its subject.

We have identified that there are three strains of the virus, its power is a unit of 10to the power of 1440 major complex virus systems (MCVS), this is our specification [2].

Based on that information, the first design of the treatment was designed and mixed. It was tried on the virus specimen of the third strain.

The result indicated that 85% of the virus was destroyed by two doses of 1800 mg/two capsules, twelve hours apart. This translated at about 70% of the strongest strain. Two more designs were made and tested until we reached the treatment and cure. This is composed of two doses of 1800 mg/dose of the treatment taken twelve hours apart. A third dose may be taken if any fever or symptoms are still apparent in the patient [3-5].

Conclusion

This is a new re-appearance of a somewhat older virus. It is slightly different but the basic structure is similar and has been defeated before.

Both appear to be attached to some animal and transmitted as a by product of the process. Based on our previous studies, and the similarities between the two viruses, we have been able to extrapolate the treatment and cure and designed a safe treatment to eliminate the virus in three doses, of 1800 mg, per dose, taken every twelve hours. Our theoretical simulation of the treatment eliminated 100% of the virus in 24 hours, but the third dose is to eliminate testing for the strain. The only limitation is that the patient will have to be able to swallow the capsules.
