

## **Covid-19, as it Mutates and Spreads; What are we Doing about it?**

### **Abstract**

For the last 24 months, almost all authorities trying to Control the spread of Covid-19 pandemic, have failed. The Virus keeps “mutating” and spreading.

Probably from the fundamental misunderstanding of the constitution and action of the Covid-19 Pandemic, how it reacts and spreads in an environment. The misunderstanding that a cure will not resolve the problem, but some kind of herd immunity and mass inoculation of the populace, will achieve great benefits to the vaccine makers, produce a tremendous growth potential for the vaccine makers, reduce scrutiny of their product, reduce investigations about their effectiveness, whether they work as intended or not, let the trials prove that. 1. A UK or Kent variant (also known as B.1.1.7) now dominant in much of Britain, has spread to more than 50 countries and appears to be mutating again?!
2. A South Africa variant (B.1.351) found in at least 20 other countries, including the UK.
3. A Brazil variant (also known as P.1) detected in four travellers to Japan which has now been found in the UK.
4. There is no evidence that any of them cause much more serious illness for the vast majority of people who become infected.

The UK, South Africa and Brazil variants could be much more contagious or easy to catch.

All three have undergone changes to their spike protein - the part of the virus which attaches to human cells.

As a result, they seem to be better at infecting cells and spreading.

5. It involves a key mutation - called E484K - that may help the virus evade parts of the immune system, called antibodies, that can fight corona virus based on experience from prior infection or a vaccine.

UK variant has mutated again, scientists say.

The Brazil variant emerged in July and has this E484K mutation too.

This is well and good, but what have the Governments and the Pharmaceutical Companies done to actually help the patients instead of just making the motions that they are doing something?
