

After Three Years: Does any Company have a Cure for Covid-19 and All So Called Variants?

Abstract

Covid-19 has been with us now for close to three years. Many developments have occurred in the fight against Covid-19. The tide starting turning when Vaccines were introduced to combat this lethal pandemic. However, there has always been a great deal of controversy in this fight against Covid-19, whether it is about the efficacy and effectiveness of the vaccines or whether or not there is a valid cure for this pandemic. Three years later, many have been vaccinated, many have had several booster shots, to counter the new variants that keep being announced, sometimes weekly and other times daily. The fatalities from Covid-19 have gone considerably down, but infections keep fluctuating. Vaccines do not appear to be able to protect against all variants, as pharmaceutical companies proclaim, and the need for booster shots is announced.

There has not been a breakthrough cure for the Covid-19, but two treatments proclaim that they can reduce treatment time to five days.

This is in contrast to the vibrational herbal medicine which proclaims to have a tried one- day cure albeit on a small scale, and also a vibrational herbal vaccine that gives immunity against all types of Covid-19 and all its variants for a period of nine months, again on a small scale.

Regrettably no agency, Pharma company or any interested party have tried to refute our claims, for the one day Herbal cure nor our nine-month herbal vaccine.

Introduction

1. Covid-19 has been around now for close to three years. It came strong and fatalities were quite high, Healthcare facilities were not able to cope with the onslaught of patients and deaths were counted in thousands per day.

Although it was discovered to be part of the Sars family of viruses, it seemed to be out of reach for Large Pharmaceuticals to act to contain this pandemic, or at least that's what appeared to all of us.

2. The virus was widely studied, and its photos were all over the research magazines and it was easily accessible through Google on the internet. Through the photographs in the media of the shape and design of the virus, we were able to start studying this powerful and deadly virus. We revived an Ancient Technique employed by the Ancient Egyptians, and by other Ancient Civilizations. This technique depended in identifying viruses and ailments by their energy levels. This technique was revived, using many references in the literature that dealt with Ancient Wisdom. A paper on the research was published in Explore Magazine, of Prescott, Arizona, in 2001, and was modified and republished under "The Basis of Scientific Advancements in Ancient Times" Published in *EC Clinical and Case reports*, January 1st, 2022.
3. Several papers were written to explain how we can detect and identify ailments using that technique.

The new corona virus (Covid-19)

1. Early January, 2020, as the new Corona virus was slowly spreading, I started to study it to try to find a cure. Using this technique, back in 2003, an herbal cure for Sars was made and which I passed on to the Chinese Embassy. Various images of the known New Corona Virus were analyzed, trying to determine The Shadow Energy Characteristics of the Virus, and whether there is one set of Energies or more than one. The images were not very different, as this was the first set of Virus Fingerprints, their shapes would change later on, as it spread and gained knowledge of transmission and adaptability. These changes would take some time, but depended on the genetic characteristics of the Virus.
2. Our investigative studies indicated that the Virus is most probably occurring in nature, that it may have been transferred from a dead animal carcass to a human. It also indicated that the Covid virus has three distinct different Shadow Energy Groups, each controlling a type, with each type causing different symptoms in patients:
 - a. **Type I:** This is the most powerful of the three types, and it may have been the first wave that hit Europe and the USA. It does not respond to antibiotics and quickly attacks the respiratory system of the patient. This is characterized by the shadow energies:
 - $Q = -32$
 - $Y_n = -32$
 - $Y_g = -32$
 - $\Omega = -12$.
 - b. **Type II:** This considered slightly weaker than type I, and from future studies mostly all variants: delta, beta, sigma and whatever other names, are all type II. Omicron is type II. Whether it is easily transmissible, causes long covid or whatever, it is still type II: Its shadow energy characteristics have always been:
 - $Q = -28$
 - $Y_n = -28$
 - $Y_g = -28$
 - $\Omega = -10$.

All Covid-19 patients who have not been vaccinated by any type of vaccine should take the infection seriously, rest and take whatever the cure protocol is. However, there is still no effective chemical cure that can eliminate any of the types, in totality.

c. **Type II:** Is the weakest of the types but it is still a Covid-19 type. It has to be treated with caution and respect, simply because modern science cannot distinguish among the three types. Only someone with vibrational skills and who is trained to do so, can the shadow energy characteristics of type III:

- $Q = -24$
- $Y_n = -24$
- $Y_g = -24$
- $\Omega = -8$.

The shadow energy characteristics of the types have not changed since they were recognized.

The surprising phenomenon is that the variants have not diverged from the characteristics of type II.

Vibrational herbal treatments and cures

Having identified the three types of the Covid-19, it became imperative to find a cure.

In the vibrational technique, once the shadow energy of the ailment or virus is identified, the design of the vibrational Herbal medicine is designed to eliminate parts of the shadow energy with each dose of the treatment. The design of the treatment depends on the size of the virus, the power of the virus and the strength of the cure base.

This process used to take many trials to determine all the components of the cure, however, with years of practice, it may be completed in a few short days:

- a. The first vibrational herbal cure was made and was designed to eliminate the shadow energy of the type I Covid-19 as it is deemed the most powerful of the types. - c. As the previous two cures were successful, we tried for an unprecedented feat: an herbal mixture that will eliminate any type of Covid-19 in 24 hours. I increased the size of the cure base and proceeded to obtain a vibrational herbal medicine to eliminate any type of Covid-19, by my definition, or any other definition i.e. beta, delta sigma, or omicron. To us, the shadow energy picture is that

of type II, and that has not changed when the variants appeared. We used the new cure tens of times, on patients in different stages of the disease, and it was successful every single time: it eliminated the total shadow energy in less than 24 hours and the patients were totally cured.

Chemical treatments made by pharmaceutical companies

Until today, there has not been any one company that has claimed that it has a 100% cure for Covid-19. Some treatments reduce the symptoms, reduce the pains and reins in parts of the virus, although two major players on the World stage have proclaimed that their new product will eliminate the Covid-19 virus in five days. This is totally untrue. Their products, based on our methodology and analysis, will only eliminate around 50% of the shadow energy of only type II Covid-19 virus or variants, but will not eliminate all of the residual shadow energy. The second product fairs slightly less, as it eliminates around 49% of the shadow energy of the covid-19 virus, also in about 5 days. The effectiveness of both drugs becomes quite lacking with type I Covid-19 infections, it would eliminate roughly 25 to 30% of the shadow energy of type I Covid-19. Vibrational herbal vs chemical cures

We have mentioned three different three different vibrational herbal treatments to eliminate any of the categorizations we attributed to the Covid-19 virus, type I, type II and type III. Covid-19 vaccines

As evidence, the death rate decreases, the symptoms are not as severe as they used to be, therefore the vaccines are doing well, they have the governments approving the new vaccines for the new and improved Covid-19 Virus.

Our analyses of this whole vaccine scenario are simple:

1. None of the vaccines from any of the drug manufacturers can actually defend against type I of the Covid-19 strain. Most of all vaccines will defend against a maximum of 80% of the type II and type III, probably around 90% for type III. However, the symptoms once you are infected are less severe.
2. Our studies on the variants conclusively prove that they are all, until now, of type II. No shadow energies have been shown to have changed among the various variants that they clamor about, just to scare the governments and they can make more money on the new and improved vaccine, which is usually very similar to the older vaccine. However, it is labelled as the one to stop this new "variant" whatever they allege it does. Just today, I measured the latest variant BA-256, lo and behold, it is a type II variant.
3. The least effective vaccines are those made either by China or Russia.
4. No one has yet to publish that a cure for Covid-19 has been reached. The two publicized cures only eliminate around 50% of the Covid-19 virus (Type II), nothing is mentioned about type I. To affect a cure of the patient, other drugs have to be given to totally eliminate the Covid-19 shadow energy.
