Covid-19 EG 5S, Is It Really a New Variant?

Abstract

The re-emergence of Covid-19, named as (EG.5 S), known as Eris, (XBB.1.1) or BA.2.86. known as Pirola, brings about several statements concerning whether or not they are new variants, or a mutation of the old Omicron variant, with minor modifications, or whether it is a new variant, not closely related to the previous Covid-19 variants that wreaked havoc on the world, or they are something new.

Two major assumptions are made. The first is that it is a variant, but a mutation of the Omicron variant (XBB.1 5), and the second is that it is a new variant (EG. 5 S), also that BA.2.86, is also a new variant.

Using the analytical techniques of vibrational herbal medicine, we studied both these variants and discovered that all three are what we classified as "type I" of the three different types, identified in our manuscript of February 2020. This is probably the type of Covid-19 that plagued China and most of Europe, even Egypt, in the early period of infections especially Italy, France, Germany and the UK. This is the most virulent of the Covid-19 types, and which none of the available chemical vaccines can protect from, nor any of the known cures totally cure. The only totally effective vaccine is our vibrational herbal vaccine, and the only cure is the one-day vibrational cure. Both are totally herbal, effective and safe.

Introduction

Back in January 2020, as soon as we were able to make an assessment of the new plague that was announced in China, and images of the new virus were published, we used these images as our new specimens to study the new virus.

Our methods have been outlined previously in several publications, it involves the measurement of the Shadow energy levels of the virus, and determine if it has other genotypes, and determine what the Characteristics of these Genotypes are. This method was used by the Ancients and rediscovered by us.

This was published and explained in the manuscript "The assessment of ailments by the ancients using vibrational herbal medicine".

The method we discovered and perfected over time, helps in determining the power of the virus, its volume, how many genotypes or other types, and the characteristics of each. This helps in determining a strategy to define and eliminate the different types of any virus.

In the study published on February, 11th 2020, in "EC Clinical and Case Reports," in Ecronicon open Access, in the UK, we indicated all our findings, concerning the new corona virus; using the technique of vibrational herbal medicine, these findings have been corroborated over the following three years, and the consequent discoveries of all these variants, to be exactly identical to our classifications of the three main types of the new Covid-19 virus. Taking into account the time difference, the additional knowledge, all the different vaccines and theories about the spread and destructive power of Covid-19.

We have now reviewed several images (specimens), of the so-called new variant of Covid-19, this has been labeled as EG 5S. These images have been obtained from various sources, and we have investigated the shadow energies of all these specimens. One particular specimen stands out and that is that of the main categories of the Covid-19 Virus, as published through "intermountainhealthcare.org".

It has divided the Covid-19 as type A, type B and type C. This typification of the three, is very similar to my classification made in January 2020. This was based on the strength of the shadow energies, of each one of the discovered types, the size of the type, the power of the type and volume of the type.

We obtained the images, from various sources, of the new variant: EG 5S, and examined the Shadow energies emitted by them. They all gave the same Shadow energy signature as that of Type I in my classification which was made and published as stipulated above.

Procedure

- We started to analyze each one of the images obtained for the new variant and other images from the various sources, to try and make an identification of all these different types.
- 2. From Intermountainhealthcare.org the type A of the Covid-19, gave the following shadow energy results:
- Q = -32
- Yn = -32
- Yg = -32
- $\Omega = -20$.

These results are similar to my classification of type I mentioned in the manuscript of January 2020.

- 3. The second classification type B, gives the following shadow energy characteristics:
- Q = -28
- Yn = -28
- Yg = -28
- $\Omega = -14$.

This is also very similar to the values attributed to my type II classification mentioned in the January manuscript.

- 4. The third classification labeled type C gives the following shadow energy characteristics:
 - Q = -24
 - Yn = -24

- Yg = -24
- $\Omega = -12$

This is also very similar to the values attributed to my classification of type III of Covid-19 in the aforementioned, February 2020, manuscript.

- 5. We have also studied many of the various variants that have appeared over the last few years of the Covid-19 virus, while being labeled by so many names, they did not deviate from being either types I, type II, or type III.
- 6. These were labeled alpha, beta, delta, iota, gamma, zeta, epsilon and eta. They were all type II, and some type III.
- 7. To be precise, alpha was measured out to be type II.
- 8. Taking each new labeled variant as it appeared, and measured it according to vibrational methods, all appeared to indicate that they were Type II of my scale, also similar to classification B which is used now by some organizations.
- 9. The very interesting finding is that we started our classification as early as December 2019 and January 2020, some specimens, from infected parts of the world, such as Italy, China, France Germany and some few specimens, which we had access to in Egypt, were probably type I.

Egypt had an onslaught of such infections, where most of the patients did not survive.

This was clearly evident in some members of the armed forces. Our analysis of these was that most were type I, and it would have been extremely difficult to heal them with the medications used and the protocol employed. The very few who were saved, were saved because we were able to identify these cases as Type I, and gave them, unobtrusively, the Vibrational Herbal cure to eliminate the new virus totally in three days and later only in one day. Another reason was because they were lucky, somehow.

- 10. In one very interesting case, we identified that the prime minister of one European country, had been identified as type I, and we wrote to their embassy that we have a cure and can help, but were totally ignored; the PM almost did not make it, the attending physicians had not yet been educated as to how to treat this puzzling new virus.
- 11. We informed most governments, by email, around the world, that we have identified, classified this new virus, and produced a cure, albeit, an herbal one; but we received formal formatted replies that they would revert back to us, sometime later on. The "push" was for the so-called vaccination, by some not so effective vaccines, to finally obtain the "herd immunity", and finally contain this new virus.
- 12. After the first wave in the spring and parts of the summer, of 2020, most all new variants were type II, which are less severe than type I, and may be cured by whatever rudimentary medicines that big pharma came up with.
- 13. In my final manuscript, published in December 2022, we predicted that, in the near future, this virus will reappear, while not one single scientific establishment has yet, to actually de-cipher the simple Covid virus design, and produce a simple one- day cure like the one we made in the summer of 2020, and which is still potent, effective and valid.

This so-called new variant: {EG 5 S}, XBB.1.1 and BA.2.86

 Lately, Covid-19 is re-emerging, slowly but surely, and since it has changed slightly, and allegedly, to make some new money in vaccines, it is now labeled as a new variant of Covid-19 and that it spreads fast, but the symptoms have yet to be attached to this new variant. 2. The one way to go to identify the characteristics of this variant, is to identify its shadow energy characteristics, and whether it is similar to, or different, from all previous variants identified over the last three years, and if so, how different, and whether or not there is some basic differences that will identify it as a Covid-19 variant and that it follows the known path of infection and cure, or not. One main question, does resemble anyone of the three classifications of covid-19 types?

As mentioned above, we downloaded many of the different images of this new variant, from the various available sources: (References: a-www.dailymail.couk/news, b-www.bbc.com, intermountainhealthcare.org, c. daro.qub.ac.uk, d-metro.co.uk). These are to serve as our specimens of this new variant. There is also evidence that a new mutant of the Omicron variant is now appearing as XBB.1.1 which we have studied below. The third variant appearing is Pirola, BA.2.86. It also has the same shadow energy characteristics as type I.

3. We then proceeded to measure the various shadow energies exhibited by each specimen downloaded.

The shadow energies are found to be as follows:

- Q = -32
- Yn = -32
- Yg = -32
- $\Omega = -20$.

Referring to our published manuscript of January-February 2020, these are similar to what we labeled as type I, and which appeared for a short time in various parts of the world caused a large percentage of deaths, as there was no ready cure, and then was replace by the so many different variants, called alpha, beta, iota, zeta etc..., which were all deemed to be type II, which are basically easier to treat than type I.

Results

- a- From all the evidence that we examined, and the studies that were made over the last three years, this so-called new variant, is not new, but it is the COVID-19 type I, or classification as classified by others.
- b- In February 2020 manuscript, we defined the action and consequences, before the fact, of the infection of any one patient by one of the three types of Covid-19. Our assessment then, was: Some findings on the characteristics of the strains:
- In the first strain, symptoms appear six days after infection. Pneumonia will appear two days later. Respiratory failure may occur after 10 days of infection.
- In the second strain, symptoms start to appear seven days after infection, and pneumonia ensues after the eighth day of the infection.

Respiratory failure may occur on the 12thday of the infection.

• The third strain is the weakest of the three, in the sense that it takes longer for the symptoms to appear, and may or may not be more deadly than the others". Some patients reacted similarly to our predictive concepts, others varied, but for type I, the results were usually pre-determined.

These were the initial conclusions written before the Covid-19 became the pandemic that it became.

c- Our conclusions today, are tempered by after the fact results and conclusions, that have occurred over the last three years.

It is interesting to note that all three types have the same characteristic lattice design.

They only differ in their respective shadow energy characteristics, as mentioned above.

From the vibrational shadow energy perspective, it is the value of the shadow energy that determines the power and effects of each type of the virus.

- d- Many of the pharmaceutical companies have been working in making vaccines, and as soon as they allegedly, identify a new variant, they start working on a new vaccine or a booster shot, to enhance the immunity of the inoculated person.
- e- We discussed the effectiveness of most of the chemical vaccines produced, with so much fanfare, and more of the same, when introducing a new booster of any new variant. Our initial conclusion of studying the vaccines, is that most will not protect against type I, but would reduce the symptoms of types II, and type III infections. The Chinese and the Russian vaccines are much less effective, even against the weakest types of Covid-19.
- f- Throughout the period of the pandemic, various cures were produced by several research companies and research institutes, with varying degrees of effectiveness, however, two cures were produced, by two major pharmaceutical companies, which we thoroughly examined, using our vibrational method, to determine their efficacy and whether or not, they will perform as prescribed.
- g- Our methodology is simple, in our evaluation: If this "cure", "can eliminate all of the effective shadow energy, or what percentage of it, and in what time frame, and reduce the suffering of the patients, then it is effective, up to the level of improvement they make in the condition of the patient.
- 1. The first "cure" eliminated @ 49% of the shadow energy of type II Covid-19, current variants, whether they were alpha, beta, zeta etc. of the variants, available to cause infection of patients. These results are obtained, in the patient, over a period of five days; then we have to find some other means to eliminate the remaining active part of the Virus.
- 2. The second "cure", made by another big pharma company, eliminated only @ 45%, of the shadow energy, of the then prevalent variants. Again, these results are accomplished over a five day period of treatment. To finish the treatment, some other form of treatment has to be followed.
- 3. We checked these two cures against the type I, which, at that time, was replaced by other type II variants that were prevalent, and our findings were as follows:
- a. Cure 1, 49% effective against type II, appeared to be able to affect the shadow energy of type I, as follows:
- 0: from -32 became -24
- Yn: from -32 became -24
- Yg: from -32 became -24
- Ω: from -20 became -18.
- b. Cure 2, 45% effective against type II, appeared to be able to affect the shadow energy of type I, as follows:
 - Q: from -32 became -30
 - Yn: from -32 became -30
 - Yg: from -32 became -30
 - Ω: from -32 became-29

This, to us, means that cure 2 is really not effective at all with type I, not only that, but it takes five days to reach that level, with no appreciable positive change in the condition of the patient, but most probably, worsening of the condition of the patient. There aren't new more effective cures that have been introduced of late.

4. From the above study, it appears that the so-called cures, may not be able to handle this emergent new variant. In all probability, new approaches are required to be able to face the new wave of Covid-19, if it is type I.

It may appear that the methodology used in the research of this new emergent Covid-19 may have to change to obtain tenable results.

- 5. Not comparing our resource to the huge resources of pharmaceutical research, we have, over the last three years, been able to reach very powerful results with Covid-19 and other ailments.
- 6. There is now talk about a new variant, resembling the Omicron variant called XBB.1.5 as resembling omicron but more contagious, in addition to EG 5.S and "Pirola" BA.2.86.
- 7. We did our investigations, on the three so called variants, and all indicated that they are both type I. This means that we do not have the chemical vaccines for either, nor do the two cures mentioned above, will eliminate, or even affect, in the healing of such variants' patients.
- 8. Some new cures will be needed. However, if one may condescend to try a different approach, that is, try the vibrational approach, we have a one- day cure, for any variant, that is, for any of the three types of Covid-19, that we have identified, in addition, we have a nine- month valid vaccine against any of the types, and which has proven to be totally safe, effective and is not chemically based. It is fit for people of any age and effective for all.

Conclusion

From the above procedures and the close study of the so-called new variants, whether EG.5.S, BA.2.86; or the XBB1.1, where all appeared to be identical to classification A, or type I, in our shadow energy classification, as indicated above.

From the current information available on the status of Covid-19 new cures, there does not appear to be anything in the foreseeable future, that may actually be labeled as a sure cure of any Covid-19 variant.

We must, in all fairness, mention our one-day cure: "The magic bullet cure", our herbal one day cure, which eliminates any Covid-19 variant, in about 24 hours.

The second question addressed is that of the ability of the available vaccines to ward off this "new" variant, which to us is type I, of the Covid-19 virus, which no research center or pharmaceutical company has been able to totally eliminate. Type I is much more powerful. The only approach is that we need a totally new booster vaccine to fight off this new threat, or a revolutionary new approach, not following the procedures of research giants or pharmaceutical companies, that appear to postpone cures for palliatives. Again, in all fairness, we have designed, and proven that our herbal vaccine, is much more potent than anything produced so far, it protects against any Covid-19 variant, and is totally effective for nine months. No chemicals, no side effects, no controversial "chip", compatible with anyone and children can take it safely [1-17].
