Treatment of Parkinson's Disease Revisited

Abstract

In 2020 we published a manuscript "The treatment of Parkinson's disease using herbal vibrational medicine and the laws of ancient wisdom". Our conclusion was that Parkinson's disease (PD) is of Viral origin. We designed a treatment mixture to totally eliminate the virus using techniques of the Ancients. We successfully used that treatment over several years to improve the condition of PD patients. Recently, we encountered several PD patients who, taking the virus elimination treatment, did not show any improvements. They continued to suffer some symptoms that may be attributed to PD, but others were different and severe in nature. Upon further studies, these symptoms appeared to be caused by the side effects of two main chemical agents in the prevalent Treatment Protocol. These two chemical agents appeared to form focal shadow energy points that fed the feeling of the side effects and the discomfort of the patients. We identified the focal points of shadow energy of each of the chemical agents and designed mixtures to eliminate such points. It is our opinion, that the treatment of PD has to change, to take care of such severe side effects, so that the effects of the treatment is felt and actually change the condition of the patient.

Introduction

Over the last twenty-five years we studied and treated many Parkinson's disease patients.

In the beginning, we were trying to identify what the cause of the disease was. We established that it is viral in origin. In the ensuing years we tried to establish the size of the virus, the power of the virus, whether it has strains, and if so, what are they. Then, tried to eliminate the outward symptom of trembling, tremors and instability. We were able, in several instances, to reduce, and in many cases, stop the trembling phenomenon, by using different mixtures until we stopped the phenomenon.

During those times, very few people were diagnosed as having Parkinson's, as MDs were not familiar with it in Egypt. Some were given the circulating treatment protocols, usually obtained through foreign pharmaceutical companies, as there was little or no research conducted on this disease and similar ones, like Alzheimer, MS and or MD, and ALS, to name a few, in Egypt. The common understanding was that a malfunction in the brain, in the secretion or production of certain chemicals, may cause such diseases in various forms.

Our research, over the years, indicated otherwise, and that all are basically caused by viral origins and can be treated, and reversed, if identified and treated early on. This was the case with one MS patient, who is totally healed now, another two from Alzheimer, several were improved in their Parkinson's condition. Most of the Parkinson (PD) cases, had the disease, but were not diagnosed until later during the course of the ailment. It did not appear to be an easily recognizable disease then.

These were the cases presented to me, haphazardly, when none of the chemical treatments on the market made much difference, in the long run. Most of the cases being treated by the prevalent medication, maintained their condition, and started to deteriorate over time. The common conclusion was, that the condition was getting worse and more medicine was needed. In all these cases, the side effects of such medication were looked upon as an acceptable consequence of whatever improvement the patient was convinced, he/she, have reached.

Lately, several PD patients approached me to try the herbal vibrational treatment that I designed, to reduce, but mainly to eliminate, the cause of the disease, as we had discovered, eliminate the virus causing (PD). Several cases had been treated over the previous few years, with excellent results, in reducing and or eliminating tremors, improving the gait and posture of patients, making them have more control of their physical activities. However, one factor became clear later, when we started treating patients who had been on chemical treatments, and were following the treatment protocols set out by the manufacturing Pharmaceutical companies. I must admit that all the medical brochures accompanying each medicine in the treatment protocol, clearly stated the various and different debilitating conditions that may appear as factored side effects. Patients differ in their reactions to different medications, but some medicines have inherent dangerous side effects as a consequence of taking that medicine vis a vis, a temporary improvement in the condition of the patient. Some of the patients tend to suffer more from the side effects than the original PD which, by now is something else, transformed by medication side effects, and deteriorating condition of the patient with time.

Procedure

In the last several months, I was approached by several PD patients, who had been under treatment with the prevalent medical protocols, based on the recommendations of the pharmaceutical researchers, and their approach to treat PD.

The vibrational herbal mixture is designed to eliminate the virus causing PD, this manuscript was published in 2020 by Ecronicon, Open Access Journal. It explained that, that happened around between 35 to 40 days depending on the patient. The progress can be measured by the reduction of the shadow energy of the virus in the patient. It is customary that when changes occur to the condition of the patient, certain symptoms, such as tremors are reduced, they show better stability, better gait, even some cheerfulness, and changes in the attitude of the patient.

However, in two of the three cases, even with a marked decrease in the measured virus power, at about 45% of the virus eliminated, one patient felt no change, plus an increase in the pain all over his body. One other complaint, one which I had never heard before in the treatments, was that he felt the energy was being drawn out of him and had no stamina at all. Another major complaint was that he had a large level of insomnia, that sleep is something that comes close to dawn, and sometimes not at all. The man felt totally depressed, and he was waiting to die to feel some relief. This was very disturbing to me as a "healer" and a human being.

The second patient suffered slightly less of these side effects. His sleeping pattern changed from early evening, to falling asleep late at night, with difficulty. He felt pains all over his body, had bouts of depression and felt, sometimes, as if, life was being sucked out of him. He did not feel that his condition was improving at all; although at that time, he measured about 50% of the virus having been eliminated. Both patients were suffering similar symptoms. My next query; what are the chemical medicines in the protocol of treatment, that may cause any or some of these changes? Regrettably, this was a question long overdue to be asked.

Different doctors treating both patients, in two separate countries, but apparently the treatment protocol was the same. Both were taking two medicines, but different doses. The first step is to study the side effects of both medicines and compare to what was happening to these two patients. The first medicine is made by a large, well known pharmaceutical giant, whose research and development departments are huge. So was the second one; well-equipped and diversified research and development programs. Needless to say, it is

not the name of the company nor the name of the medicine that is important; but what happened to the patients around the world, as a consequence of taking those medicines, be it as it may, the symptoms varied from one patient to the other in severity, but the side effects are dangerous. We are not to judge, but to illustrate the effects of these side effects on the patients, in varying degrees and how, if we can, reduce the pains. We will list some of the side effects mentioned in a company's brochure treating PD.

Apparent side effects of some chemicals in PD treatments

These are some of the side effects that require consultation with your attending physician.

These side effects do not have to be manifested by every user of that medication, but the presence of any of these side effects is cause for concern, especially if the attending physician insists that the treatment has to continue as there are no other replacement for that particular medication.

Some of the patients, on higher- than- average dosage, start to suffer more from the side effects than from the original ailment. It is at this point which physicians have to start searching for alternatives. The research into a cure may have not gone far enough with Research groups on conventional chemical research, but we insist that a cure is available, by actually identifying the main cause of the disease which is a virus, even though researchers are not able to discover it, maybe because they have dismissed it out right?

PD is a disease of Viral origin, which we have identified, and in many cases eliminated, our problem now lies in the horrible side effects inflicted on the patients by various chemical medicines that, may alleviate parts of the symptoms of PD in the short term, but exacerbate the suffering of patients in the long run.

"Another medication which is sometimes prescribed in addition to carbidopa/levodopa is Amantadine Sulphate. Sometimes going under the brand PK MERZ. Several PD treatment protocols contain one or both of these chemicals. There are strict rules and procedures required to be implemented by attending physicians, when treating PD patients, who are usually older and more fragile than healthy young patients, in general. It appears, in several cases that we checked on, the follow up between patient and physician, may not be ideal. The following is the procedural steps and actions and reactions when taking Amantadine Sulphate.

The chemical composition of the drug, amantadine, sold under the brand PK MERZ.

"Amantadine is an antidyskinetic medicine. It is used to treat Parkinson's disease (sometimes called "paralysis agitans" or "shaking palsy") and its symptoms, including dyskinesia (sudden uncontrolled movements). It may be given alone or in combination with other medicines (e.g. levodopa) for Parkinson's disease. By improving muscle control and reducing stiffness, this medicine allows more normal movements of the body as the disease symptoms are reduced. Amantadine is also used to treat stiffness and shakiness caused by certain medicines that are used to treat nervous, mental, and emotional conditions. Amantadine is also an antiviral medicine. It is used to prevent or treat certain influenza (flu) infections (type A). It may be given alone or together with flu shots. Amantadine will not work for colds, other types of flu, or other virus infections".

Drug interactions

Although certain medicines should not be used together at all, in other cases two different medicines may be used together even if an interaction might occur. In these cases, your doctor may want to change the dose, or other precautions may be necessary. When you are taking this medicine, it is especially important that your healthcare professional know if you are taking any of the medicines listed below. The following interactions have been selected on the basis of their potential significance and are not necessarily all-inclusive.

For patients taking amantadine for Parkinson's disease or movement problems (including dyskinesia) caused by certain medicines used to treat nervous, mental, and emotional conditions: often, do not take it for a longer time than your doctor ordered.

Improvement in the symptoms of Parkinson's disease usually occurs in about 2 days. However, in some patients, this medicine must be taken for up to 2 weeks before the full benefit is seen.

Indications/uses

For the treatment of symptoms of Parkinson's disease, e.g. stiffness (rigor), trembling (tremor) and diminished movement or motionlessness (hypokinesia or akinesia) as well as movement disorders similar to Parkinson's disease caused by certain medicinal products (neuroleptics and medicinal products with a similar mechanism of action) (extrapyramidal symptoms such as early dyskinesia, akathisia and parkinsonism).

Dosage/Directions

Dosage with single and daily doses: An ECG (50 mm/s) should be recorded before and 1 and 3 weeks after commencing treatment and the Bazett frequency-corrected QT time (QTc) determined manually. Such an ECG should also be recorded before and 2 weeks after any subsequent dose increase. Further ECG check-ups should then take place at least once a year.

If given in combination with other antiparkinsonian drugs, the dosage should be individually adjusted.

In patients previously treated with amantadine infusion solution, a higher starting dose can be chosen.

In the event of an acute worsening of parkinsonian symptoms in the sense of an akinetic crisis, amantadine infusion treatment should be administered. www.drugs.com, www.healthline.com, www.mayoclinic.com".

The shadow energy manifestation of the side effects of chemical medicines in the treatment of PD

1. In our studies to determine means and ways of eliminating the addiction to some chemical based substances, mainly Heroin, we discovered that invariably, any usage of such a substance leaves a residual Shadow Energy Component in the brain. This component increases over repeated usage and becomes the force of addiction on its own. This Shadow Energy may not be apparent to researchers

- using conventional methods, nor will they be able to eliminate it, as it is the process to start the healing process of eliminating or just controlling addiction of any sort. This is not only with Heroin, but our studies, a few years ago, on cigarette, or tobacco addiction, indicated such an unknown energy, which we, by accident, tapped, but could not definitely identify.
- 2. It appears that by studying our PD patients, suffering from severe side effect reactions, to some of the treatment medication in the PD protocol, we discovered several Shadow Energy Components in the brain caused by the repeated usage of some of the chemical medication prescribed as part of the treatment protocol prescribed by the Pharmaceutical manufacturers, with all the warnings of possible side effects of such medication. However, the symptoms apparently caused by these medications, which actually, in some cases, followed the exact side effect statements published by the drug manufacturers to the letter. The recourse in the brochure, usually, is refer back to your attending Physician, who usually is at loss to change anything, other than replace one medicine by another similar in composition to the drug that may be causing the complaint of the patient.
- 3. One physician insisted that the suffering patient has to continue the same medicine, as he did not have any other alternative. If I may add, that patient, at that time, based on our own estimates, had practically eliminated, by our count, 97% of the active PD Virus. He should have been free of the basic symptoms caused by PD; instead, he was suffering due to the side effects of the medication. His MD could not change the medication, we tried to reduce the dosage of one drug from one tablet, half twice a day, to half a tablet daily. He did that for a week, but did not feel any improvement, so the advice was to go back to the one tablet daily. Nothing changed. We needed to extend the period of reduction of dosage, but the patient demanded that he return to the original dosage.
- 4. The open course is to identify why such deterioration happens, and whether or not one may be able to stop and reverse the consequence of it. This deterioration appears to happen due to the interaction of some of the chemicals included in the medicine, or it is another reaction by the medication in its reaction with the chemistry of the body. It appears to be a common occurrence in patients who take these two named substances, in whatever form they are, and the effects appear, shortly if the dosage is high, or after a prolonged period, if the dosage is low. High and low are subjective values that depend on the reaction of that particular patient.
- 5. Some observations are noted:
- 1. The side effects of both medicines have been established, by different patients, and probably conveyed to the appropriate attending Physician. This physician, should have some responsibility to convey his findings, if significant enough, to the Pharmaceutical representative selling him the benefits of such a drug.
- 2. The physician, and the Pharmaceutical companies, must have taken steps, to either eliminate the adverse side effects, or find an alternative treatment not based on the same chemical. Or at least explain why patients are relieved of one ailment to be saddled with another, which may be causing a great deal of harm to patients, thus eliminating the reason to take the medication in the first place.
- 3. We have, in our study, been able to discover such Shadow Energies due to the emergence of the side effects energies, due to both different chemicals, in addition, the side effects Shadow Energies due to the Addiction quality of such chemicals.

The above tables indicate that both chemical substances used in the treatment of PD can actually create some Shadow Energies associated with side effects that are mentioned as adverse reactions, possible to happen to patients using those two chemicals, with their brand names or under different generic names. Based on our previous studies, we were able to determine the Shadow Energies of both medicines side effects, and prepare an anti- side effects treatment to eliminate, slowly, the side effects of each chemical.

As in any addiction case that we have studied, it became clear that such Shadow Energies have to be eliminated, for the patient to feel well again and to be able to overcome the need of taking that particular medication. We also found that side effects are similar, but are varied in their severity in different patients, depending on the duration of exposure to such chemicals. The process of eliminating the side effects is not simple. The patient had been using this chemical for a long time, developed some sort of addiction, which has to be eliminated for the patient to truly benefit from actual improvement in their condition.

- 8. With one patient, patient 2, we tried to reduce one of the medicines and allowing him to take the side effects elimination mixture, he tolerated the side effects mixture, but did not feel better by reducing the dosage. He returned to the original dosage again, but had some difficulty in tolerating the chemical Medicine once again, for a few days. We stopped the side effects mixture and returned to the chemical medication, with no improvement in his physical condition, anyway. In one instance only, we cannot draw any specific conclusion. We can only surmise that the side- effects, affecting the patient, may surpass the effects or the original ailment, in scope and severity.
- 9. Another patient who was suffering from several classic side effects of the chemicals due to PD treatment protocol, we tried to eliminate some of these side effects, by administering the anti- chemical side effects treatment for several days before starting the small reduction of the chemical medicine. The first day, after the reduction of chemical medicine by a quarter, he reacted as if he is talking to imaginary people, quite agitated, fidgeting, this lasted for a few hours, then he reverted back to a normal steady state. He is still in the beginning phase of the trial to wean him from some of the chemical medicines. He is apparently totally free from the PD causing virus, according to our estimates. He is currently feeling much better, and continuing the anti-side effects mixtures.

Any patient, to undergo the elimination of the side effects of whatever chemical compound he/she are taking, should be under complete medical supervision and only after they have taken the mixtures to eliminate the PD causing virus, if this is at all possible.

This is a question that needs to be addressed, as there appears to be a new step to take in the treatment of PD, the question that there is "no cure" is no longer valid, the real question is how to eliminate all the harmful side effects of the chemical medicines prescribed in the protocol of treatment. This protocol was designed when the prevailing wisdom was PD is incurable, we do not believe that this is the case anymore.

A new development has occurred in our latest studies on PD and the side effects due to chemical compounds, we have reached a research result of being able to design a Vaccine to prevent the infection of PD for over 20 months. It appears that at a certain energy level of the body, the body becomes susceptible to infection by the PD virus. Although the results are conclusive, the condition under which it may be applied are not yet certain. When to give it to a patient, what are the characteristics of that patient, any specific age group etc. Even though we have determined the cause of PD is viral, we have not been able to establish its form to infect. We have, however, been able to determine what level of shadow energy that may prove inviting to PD infection.

Results

- 1. In the course of this study which involves PD patients under treatment with the prevalent PD treatment protocols, involving the chemical medicine combinations available for the treatment of PD; we have discovered that many of the symptoms suffered by patients, in addition to those due to PD, appear to be the side effects of such chemical medication causing a great deal of other troubling symptoms to patients.
- 2. In several patients, under treatment for more than a year with the chemical medicines in treatment protocols, the results of the study, although showing an elimination of the virus in the patients, all of them did not experience any positive change in their conditions, nor did they experience any kind of change in their symptoms which they had been experiencing over a long period of time. Many of the complaints involved symptoms that are not consistent with the PD symptoms in other patients who are just starting treatments or not at all.
- 3. A general feeling of tiredness, lack of stamina, delusions, insomnia, depression and a feeling of withdrawal of the life force within.
- 4. It became imperative to find out such feelings, as the PD itself being a depressing effect. A look at the medicine used to treat those patients, indicated that all are following very similar treatment protocols, whether they live in Egypt, the Emirates or Kuwait. These side effects are not localized in one area only.
- 5. Based on the information obtained, we searched for indication of addiction due to these medications indicated in the protocols of treatment. As we had discovered previously, in treating other types of addiction, there appears to be some focal shadow energy points, one for each type of addiction.
- 6. We measured these shadow energy points for each individual, and tabulated them to observe what the table indicates.
- 7. Two tables, one for amantadine sulphate and another for carbidopa/levodopa.
- 8. The tables reveal different values for different patients, probably depending on the duration under which the medication was administered. They all indicated some clear evidence of addiction shadow energies.
- 9. The reactions of two of the patients tend to indicate that these Shadow Energies may be eliminated, and reduce the suffering of patients.

Conclusion

- 1. Our study discovered that there are shadow energy focal points in patients using chemical treatment protocols for PD.
- These shadow energy focal points indicate an addiction to some of the chemicals in the treatment, and produce secondary symptoms that are harmful to the patients and in many cases hamper the effective determination that the patient has been cured.

- 3. A complete review must be made in the treatment protocols of PD to eliminate all harmful side effects of the chemical treatments.
- 4. There is a great deal of energy to rid the patient of any of the addictive side effects of the chemical medicines, but if the anti-addiction mixtures are administered, before the scaling down of chemical medicines until they are totally eliminated, the results will be quite definite. However, this is based on the theory that the PD virus is eliminated first.
- 5. From our study, and the determination of the PD virus and its elimination, we designed a Vaccine to prevent the infection by PD. However, the timing, eligibility, status and condition of the candidate, have to be determined in a different study.
- 6. This PD vaccine is effective for 20 months, and will not allow any infections during that time [1-16].
