Is JN.1 a New Covid-19 Variant, or is RSV the Latest Variant?

Abstract

There is now a slight surge of Covid-19 is appearing in many parts of the world. There appears to be some changes in its symptoms, like the variant being labelled as JN.1. At the same time, another virus is going the rounds which appears to be more severe, and with some changes in the symptoms. This new virus is being labelled "RSV". In this study we studied the differences between them and whether or not RSV may be named as a variant of Covid-19.

Our vibrational herbal medicine (VHM) analysis indicated that they are not of the same family, that the shadow energy characteristics of the RSV Virus are larger than those measured for any of the Covid-19 types.

Our new VHM treatment for RSV will eliminate any variant of Covid-19, while the VHM treatment for Covid-19 will only reduce the power of RSV by about 40% but will not eliminate it. Our conclusion is that they are two different viruses.

Introduction

"Covid-19 EG 5S, is it really a new variant?", in this manuscript, published in Ecronicon magazine. It discussed the possibility of new and maybe more dangerous Covid-19 variants. Our analysis which is based on our vibrational herbal medicine (VHM) technique, which we have derived over last twenty-seven years, from the basis of ancient Egyptian medicine. Our analysis of the variant "ES.5" indicated that it simply had all the same shadow characteristics of type I of Covid-19, and did not constitute a new variant. Our concept of a new variant is that the shadow energy characteristics would not resemble the well-defined shadow energy characteristics determined previously, of types I, II, or III; and that it will have a slightly different shadow characteristic profile.

This new, so-called variant, making the rounds around the world, and closely monitored by medical research facilities and hospitals, is labelled "variant" JN.1. Our method to determine whether it is true or not, is to measure its shadow energy characteristics and compare it to our previously established values for these three types of Covid-19.

Procedure

In our study, we measure the four main shadow energies of the virus. Usually obtained from one of the images taken of the virus. The following are the shadow energy characteristics of JN.1:

- Q = -32
- Yn = -32
- Yg = -32
- Ω = 14.

These shadow energy values are quite similar, if not identical, to those obtained for all of the specimens of type I, Covid-19 specimens.

Another test is to measure the reaction of the virus to the (VHM) one day cure, which we designed and was proven totally effective against any Covid-19 types. It eliminated all the shadow energies of the virus in 24 hours: Two- 900 mg capsules every twelve hours are sufficient to eliminate the virus. We are not certain as to how treatments of this new virus are undertaken as the situation is muddled by the presence of a new virus (JN.1), which appears to have similar characteristics as the Covid-19 ones, but may react differently. The reaction of this "variant" is consistent with the normal reaction of the cure to the virus: it is eliminated in less than 24 hours. We can positively determine that this is a Covid-19 variant similar to type I Covid-19 types identified previously.

The second virus, which has been largely labelled as (RSV) virus reacts differently with patients, and appears to have more severe symptoms, and does not react well with the regular flu medications.

In order to study this virus more thoroughly, we study its shadow energy characteristics, and determine how similar or dissimilar to Covid-19 it is, if any.

After obtaining several specimens of the RSV Virus from the various sources, we began its study.

The virus exhibited the shadow characteristics of a single complex virus system (CVS):

- Q = -36
- Yn = -36
- Yg = -36
- $\Omega = -20$.

The shadow energy characteristics are slightly more than the values of type I of the Covid-19 virus.

If we compare type I of Covid-19, the shadow energy characteristics, are different by a value of -4:

- For instance, Q for type I is -32
- While Q for RSV is -36
- And Yn for Covid-19 -32
- Yn for RSV is -36
- Yg for type I is -32
- Yg for RSV is -36
- Ω for type I is -14
- Ω for RSV is -20.

There appear some marked differences between the type I Covid-19 virus and the RSV virus. It appears that RSV may be slightly more powerful than Covid-19 type I. It may mean that it is a new virus and not any variant of the Covid-19 brotherhood.

This may need further analysis to determine the differences and similarities, if any.

The Covid-19 brotherhood reacted fully to our VHM cure which is taken 2 capsules, to be repeated after 12 hours by another two capsules. These four capsules will totally eliminate the shadow characteristics of any Covid-19 type in less than 24 hours. The reaction of this new virus, which is labelled as "RSV" virus is slightly different. In the first trial, the four capsules cure, reduced the RSV shadow characteristics as follows: Q = -36 went down to -10, meaning that the virus is still active, and still affecting the body of the patient.

In the second trial, we increased the dosage of the cure to four two capsules cure, and the shadow energy of the virus was not diminished at all, it was still registering Q = -10. The Covid-19 cure does not fully eliminate the new virus and we have to design a new cure to eliminate this new virus. However, on standby, is the old Covid-19 cure, it will help to diminish the severity of the RSV until we have a sure cure for it.

Procedure to design a VHM cure for RSV

The first step is to determine the unit of the virus and then how many times is it replicated in the virus:

- 1. It is imperative to discover if there are variants of this virus or genotypes, to incorporate in the design.
- 2. As has been customary in this type of research, is to try to identify the unit of the virus that is replicated to form the core of the virus.
- 3. We followed our research procedure, to reach that the size of the RSV unit, it is 10 to the power of 1710. The size of the virus will determine its qualities and how long it takes to eliminate it.
- 4. By trial and error, we reached a volume of the active components of the virus as 2,601,000 units.
- 5. How does it fare vis a vis the VHM cure for Covid-19? Our trial indicated that it did not do well; it reduced its power, shadow energies are reduced, but did not eliminate it. It therefore, is not a new variant of the Covid-19 family.
- 6. In our years of experience to find such cures, we use a base so large as to reduce the time of virus elimination, that is a very effective elimination procedure in a relatively short period of time, shorter than the time usually taken by chemical treatments, as we have proven many times in the last few years.
- 7. We tried different scenarios to see which of the cures would be effective and whether or not it is of a wide enough spectrum that it may affect the Covid-19 family of viruses.
- 8. After several attempts at the design of a cure, we came to a specific design that would work on RSV, primarily, and may even affect all Covid-19 types.
- 9. The design of that specific mixture is as follows (Knowing the codes, the herb can be identified):
- QYn-Yg
- Q-Yn Yg
- -Q
- QYn-Yg
- -Q

- QYn-Yg
- Q-YnYg.

The preliminary results of this mixture are quite impressive, it covers the range of RSV characteristics, and will eliminate all of the shadow characteristics of the Covid-19 group.

Treatment procedure

The procedure is to find out what is the exact dosage of the treatment that will react with the shadow energies of the RSV virus and that of Covid-19. The main object is to eliminate the shadow energies of either virus. The first cure is the VHM cure for RSV, as based on the above design.

The research is directed towards the RSV virus to which the design is made. The first trial on the specimen of the RSV virus: is two 900 mg capsules as the initial dose, followed by two 900 mg capsules after twelve hours. The shadow energy characteristics of the RSV specimen after 12 hours was reduced to:

- Q = -10 from Q = -36
- Yn = -10 from = -36
- Yg = -10 from = -36
- $\Omega = -6 \text{ from} = -20.$

Taking the second two capsules after 12 hours, eliminated all the shadow energies, they all are eliminated to become = 0, this means that the total virus is eliminated in its entirety.

The dosage for the full treatment, became two 900 mg every 12 hours in one day, as it will effectively eliminate the RSV virus which is so devastating to patients. It appears that the new vibrational herbal cure is effective, safe and easy to use. The dosage for an RSV infection per patient, is two 900 mg capsules every twelve hours repeated once, will eliminate the RSV virus in any adult. The only drawback is that this treatment, can only be made in capsules, of 900 mg size. This makes it difficult for children to use it. One way around this, is to use smaller capsules, 450 mg capsules, but still, it may not be easy for children, below a certain age, to swallow them.

In the course of the experimentation, the VHM cure for Covid-19 which was made during the height of the Covid-19 pandemic, which consisted of two 900 mg capsules repeated once, will reduce the intensity of the RSV virus to about 40% of its original power (as indicated above), giving the patient a fighting chance for being cured in the regular manner, even though it is not totally eliminated. It appears, that even now, we may have some effective treatment against RSV.

The design of the RSV (VHM) cure we designed, appears to act on any Covid-19 variant by eliminating the shadow characteristics of the Covid-19 virus after one dosage of the (RSV) VHM cure. It is designed as a wide spectrum anti-viral, although the Covid-19 VHM cure eliminates only 40% of the RSV virus.

Results

The results obtained by the newly designed RSV virus, based on the VHM techniques, proved to be quite effective in totally eliminating
the shadow energies of the RSV virus in two doses of 1800 mg capsules, 12 hours apart.

- 2. The smaller dosage of two 900 mg capsules of the RSV treatment, will totally eliminate 100% of the Covid-19 variants, in one dose.
- 3. A drawback is our inability to design the cure in liquid form for children to take, as it is quite effective against this virus.
- 4. There appears to be some connection between the Covid-19 virus and that of RSV, as the RSV (VHM) cure, can cure Covid-19, but the VHM cure for Covid-19, will only eliminate about 40% of the shadow energies of RSV.

Conclusion

- 1. Our study was to determine whether or not RSV virus is a variant of Covid-19.
- 2. The evidence discovered does not support totally this idea. RSV is much stronger and more difficult to eliminate except by a special VHM cure designed specifically for it.
- 3. The RSV (VHM) cure will be able to eliminate any Covid-19 variant, but the Covid-19 (VHM) cure will only affect 40% of the shadow energies of the Covid-19 virus.
- 4. It is, therefore, possible to use the RSV treatment to treat any Covid-19 variant, but use the (VHM) covid-19 cure, to partially treat RSV with Covid-19 cure [1-13].
