

## The Treatment of Breast Cancer Using Vibrational Herbal Medicine Revisited

### Abstract

Several years ago, and after considerable investigations, we discovered that breast cancer is a viral based cancer. The cases that we investigated at that time, were cases involving recurring cancer after surgery, and sometimes after a year or less after surgery. Our assumption was that if we understand the cause of the cancer, it can be eliminated and stopped. Our final investigations indicated that it is a viral based cancer, and we were able to design a cure for the cancer we studied. The results were reassuring, as some of the lumps disappeared and the patients reacted well and became free of the cancer. Some were on chemotherapy at the time, but our mixture helped. In another case, a patient was examined after the surgery and some traces of the cancer were present. The treatment was indicated to be for 30 days and the cancer disappeared. It has been twelve years since then, and the patient is still free.

Lately, several cases were presented to us, with diagnosed breast cancer, and apparent lumps and focal lesions that are very clear. The patients were afraid of the operation and its consequences, and wanted to try a less intrusive treatment. They wanted to try the vibrational herbal medicine (VHM) treatment. They were all on some medication and in the process of having surgery as a last resort.

In three of these cases, our examination revealed that the cancer is of viral origin. The first mixture, tested on the first patient, worked quite well, and within the period of 30 days, several of the focal lesions were eliminated, with an improvement in the apparent well-being of the patient. This process was repeated with two other patients. However, several days afterwards, some of the patients indicated some negative energy characteristics in their breasts, indicating the presence of a new cancer. In each case, it was a new cancer. This was a new cancer, and did not respond to the first mixture and needed some new treatments. The patients responded well to the new treatments, and the energy characteristics indicated a positive change and even disappeared, in some cases, but a third cancer appeared with a new design and structure, needing a new treatment. All patients decided to continue other avenues of treatment, whether chemotherapy or radiation, it depended on the attending physician.

It was becoming clear that breast cancer may not be a single virus, but a group of cancer viruses, may be working together in unison, or in some kind of order, and appearing as needed, whenever the one active cancer was being eliminated. They were actually different as they needed new mixtures to eliminate. They may be slightly similar in structure, and may even be eliminated by other mixtures used in other cases, but the sequence of appearance did not have to be the same. This may be an indication that even with chemotherapy and radiation after surgery, cancer still appears after a period of time.

A new approach is required to deal with breast cancer as a group of cancers, appearing in some kind of sequence. We endeavored to design a cure to eliminate four different cancers that appeared in the three different cases studied, that appear one after the first cancer was treated. It was successful, in the initial stages, but some patients dropped out of the trial, and we could not reach a final conclusion on its efficacy. However, it did work on eliminating the active cancer at that moment.

All of the cancers that appeared followed the rules of viruses in vibrational herbal medicine specifications, except for one cancer that exhibited a slightly different characteristic, and did not appear in all cases.

### Introduction

Fourteen years ago, and after several years of experimentation, we concluded that breast cancer is a viral disease. Several cures were designed to eliminate the causing virus, and was tried on several patients over the years, but mostly on already treated patients who were experiencing re-emergence of the cancer. It is our belief, since it is a viral caused disease, eliminating the whole virus is the only way to eliminate the cause and not only by surgery or other chemical means of treatment. Better results are obtained, after surgery, to use (VHM), to eliminate any traces of cancer not removed by surgery. This will also reduce the risks of re-emergence of the cancer, regardless of how well the surgery was performed.

In one specific case, the VHM was administered to a patient after her surgery, as we discovered traces of the virus still present. Cancer has not reappeared to the surgery patient almost eleven years after taking the vibrational herbal medicine (VHM) that eliminates the breast cancer virus.

However, lately, during the treatment of three patients with breast cancer, who elected not have surgery, but try the new VHM treatment, we noticed several observations that led our research in a different direction.

### Observations

The theory in vibrational herbal medicine (VHM), that a virus is characterized by four negative forces (Shadow forces):

1.  $Q=-$
2.  $Y_n=-$
3.  $Y_g=-$
4.  $\Omega=-$

If a cause of an ailment exhibits these characteristics, then in all probability, it is a virus and we search for the characteristics of that virus, to design a treatment for it. This was the case for all four patients that requested to try the VHM treatments for breast cancer, to prevent the surgery and its traumatic experience. However, one of these patients, although the virus in it characterized those of a virus, it was slightly different. This was the case with this third case, a new patient, an older patient, about 75 years old, was diagnosed with breast cancer. She had already undergone surgery, and this was a resurgence of the breast cancer. Our diagnosis indicated the same energy characteristics, but with a slight change. The energy characteristics were as follows:

- $Q=-$
- $Y_n=-$
- $Y_g=0$
- $\Omega=-$

The difference between the standard virus shadow characteristics and this one, is that the shadow  $Y_g$  component is zero. This may make it difficult to eliminate the cancer totally, but we have not been able to determine how these changes the outcome of the results. The structure is basically different from the norm. This required a new mixture, as the other mixtures did not totally react with it. We will discuss her case later on, as the third patient.

### Procedure

The first patient, a woman of about 45 years of age, was diagnosed with breast cancer after several lumps were seen on her examination. She was asked to have her surgery soonest, otherwise it will be life threatening situation. She declined to accept the surgeon's assessment, and wanted to try the non- invasive technique of VHM.

Our initial examination determined the presence of the shadow energies characteristic of cancer. We then continued to determine the type of cancer, to be able to design the VHM to counter the effects of this particular cancer.

The cancer particulars were (Shadow energy characteristics):

1.  $Q=-30$
2.  $Y_n=-30$
3.  $Y_g=-28$
4.  $\Omega=-24$

These are the shadow energy characteristics of a virus. The next step is to determine its size, unit and power. After that, we try to design a mixture that will eliminate the shadow energy characteristics so as to stop its spread and eliminate any focal lesions that may have appeared. Some previous treatments were available, but were designed previously for other breast cancer virus, but they eliminated close to 60% of the cancer energies in about 40 days. We wanted another treatment to work much faster, be more powerful and show results quickly, and to be compatible with this new CVS.

After several trials, one mixture was designed that indicated that it will eliminate the total shadow energies of the cancer virus in around 30 daily doses of 1800 mg capsules. That would eliminate the whole virus and consequently, eliminates the breast lumps and improve the health of the patient. Therefore, new mixtures had to be designed to be more effective, and to eliminate up to 100% of the energy. The following is the final design to react with up to 100% with the all shadow energies of this cancer.

Mixture (A) to treat cancer virus [1] (Breast cancer mix 78), each determines the characteristics of an herb in the design of the mixture, all are totally herbal:

1.  $Q Y_n Y_g$
2.  $Q-Y_n Y_g$
3.  $-Q$
4.  $Q Y_n-Y_g$
5.  $Q-Y_n Y_g$
6.  $Q Y_n-Y_g$
7.  $-Q Y_n Y_g$

We continued our observation of the patient and on how she was progressing, and if there were any issues with the medicine. She appeared quite well and felt more active, open to life, and her attitude was improving quite well. There were no issues with the medicine, it was well tolerated and appeared to be beneficial to the patient. After the end of the first phase of the treatment, the patient was requested to have an x-ray to determine the status of the cancer. The following are the Energy readings of the cancer in the patient, during the treatment.

The readings progressed quite well, indicating a change in the condition of the patient. X-rays indicated that 2 lumps in the left breast disappeared, which means that the mixture was actually doing what it is supposed to do. On 13 June 2021, the preliminary exam indicated that the cancer virus is close to being 100% eliminated. We requested that the patient undergo an X-ray exam to make sure that our checks are correct. The X-ray indicated the presence of a new lump in a different place than the previous locations. The energy characteristics indicated the presence of cancer in the patient. This new cancer did not react to the previous mixture (BRC78), and we needed a new cure for a new cancer virus that just appeared. The shadow energy characteristics of this new cancer appeared to be:

1. Q=-26
2. Yn=-28
3. Yg=-26
4. Ω=-18

These are the shadow energy characteristics of a new cancer that just appeared after the first one was eliminated. The design of the new treatment was made after determining all the parameters of this new cancer. This new mixture reacted well with the new cancer and appeared to eliminate it in about 16 days, taking 3600 mg of the mixtures in two doses daily, each of 1800 mg per dose.

Our control on the progress indicated that about 94% of the virus causing the cancer [1], is eliminated; however, the x-ray indicated that two of the original lumps disappeared but another one appeared in a different place. The presence of a new lump indicates that a new cancer has appeared. This appeared contrary to the patients’ assertion of feeling quite well and having more energy. The patient is re-examined to ascertain that the elimination of the cancer virus is actually 94%, and this is confirmed; it may then be an indication of a new cancer virus [2], appearing.

It has been our experience that certain viral cancers may come in batches. One is active, is treated and suddenly, a new growth appears when one is not expected. From past experience, we started looking for a group of cancer viruses surrounding this particular cancer that we believed has just been eliminated.

We uncovered a new cancer virus that is about 20% active, and has already appeared as a lump. The procedure is always to estimate its power, size and find a mixture to eliminate it.

This new virus is similar to virus no [1], its power (indicating the replication), is similar but its size is slightly larger than no [1].

The design of the second cure for the second cancer begins, and continues, until we are able to design a second treatment mixture to eliminate cancer [2].

Before we design a cure for the new cancer [2], we must identify its shadow energy characteristics to be able to design the cure.

The shadow energy characteristics are as follows:

1.  $Q=-28$
2.  $Y_n=-26$
3.  $Y_g=-28$
4.  $\Omega=-18$

These are the shadow energy characteristics of a virus. We have to identify the virus and its parameters. It is clear that the first treatment has no effect on this new cancer as it did not react with it at all, nor did it affect any of its components. As soon as the cancer [1] was eliminated, the cancer [2] was activated and started its destructive expansion. Our efforts to design a cure resulted in the following mixture, which we labeled BRC 79, specifically, to eliminate cancer [2].

It was our belief that it may prove beneficial in future cases of breast cancer, to have several available cures for various cancers. It was becoming increasingly clear that breast cancer may not be just one cancer that may be eliminated once and for all, either by surgery or elimination by vibrational herbal treatments.

Mixture [2] BR 79, to eliminate cancer [2]: The shadow energy specs. of the herbs:

1.  $-Q$
2.  $Q Y_n-Y_g$
3.  $Q- Y_n Y_g$
4.  $Q Y_n-Y_g$
5.  $-Q$
6.  $Q-Y_n Y_g$
7.  $Q Y_n-Y_g$

The new mixture indicated a treatment period of 30 days, with a dose of 1800 mg of mixture, taken once after a meal, for 30 days. This treatment should eliminate 100% of the second virus causing cancer no [2], in that time period, give or take a few days. The patient, was dismayed by the x-ray, but was not discouraged, and continued to take the treatment for cancer [2], hoping for a relief of the cancer. She felt well, and the new mixture buoyed her spirits and hopes.

We continued our daily examination of the patient to measure the pace of her improvement by the change in the energy characteristic of the cancer. The elimination rate was progressing as predicted, and there was no indication of any other new cancer appearing in our examinations, yet. The new treatment BRC 79, was indicated for an additional 12 days at a daily dosage of 3600 mg per day, when the shadow energy characteristics did not decrease as predicted. The new amount is divided into two dosages, each of 1800 mg per dose, twice a day. The remaining dose was administered for the duration, the patient felt well and was pleased with the results.

Time came for a new X-ray, to determine the status of the progression of the treatment. This was determined a few days of completing the extra additional 12 days of treatment. The results of the X-ray were disappointing to us all, especially to the patient who was hoping for some good news. Although the original lump disappeared, two other smaller lumps appeared. The energy characteristics of the cancer

became much smaller, but new lumps appeared. This again appeared to be a new cancer [3], as none of the other two mixtures were having an effect. The patient, understandably, opted out and started chemotherapy. We hoped that she would be cured. The common denominator in the cases until now, is that when one cancer is about to be eliminated, a new one just appears again. It is interesting that we are not able at the beginning, to determine the number of cancers present, but that we are able to find them, once one is finished and the following starts to be active. We have endeavored to do just that and were able to do so later on.

The second patient: With breast cancer, had several lumps in her right breast, and she was contemplating surgery or chemotherapy. Her son was an MD who was supervising her treatment. He wanted to try VHM, as he had tried it before, on a different ailment and was cured. Our examination revealed that the mixture labeled BRC78, would obtain very favorable results with this patient. A treatment period of 30 days at a daily dosage of 1800 mg of the mixture, would be sufficient to eliminate the energy characteristics of the cancer in patient number 2. After the initial period of treatment, an X-ray revealed that three of the five lumps had disappeared but two more smaller lumps appeared in the other breast. Further examination revealed a new cancer, but was susceptible to the treatment (BRC 79). A treatment period was prescribed for 12 days at 3600 mg per day, in two equal doses. She took a few days, but her husband (not an MD), insisted for her to start chemotherapy and forget about this (VHM) vibrational herbal treatments.

The third patient: An older lady, who was about 74 years old, had had surgery previously, several years ago, but was diagnosed with re-emerging breast cancer. None of the existing treatments, BRC78 or BRC 79, had any effects on this new cancer. It was then, that we discovered that it was slightly different cancer, with one energy parameter equals zero. This appeared to be a new strain of breast cancer that we had not encountered before. It had the same power as other breast cancer types, but its size of the CVS was slightly larger, and it did not respond to any of our previous designed cures. A new cure was required and we tried to include other types of breast cancer, by increasing the base of the designed cure.

We finally reached a design cure that reacted well with this new cure, and eliminated all the cancer shadow energy characteristics in about 14 days of treatment. The dose was composed of 1800 mg of the treatment per dose, twice a day for 16 days. This appeared to eliminate the cancer energy characteristics in that duration. This case was similar to some cases tried several years previously, with great success.

The shadow energy characteristics of this special type of cancer was:

1.  $Q=-$
2.  $Y_n=-$
3.  $Y_g=0$
4.  $\Omega=-$

As several cancer viruses kept appearing, a more comprehensive design of a cure had to be made. We worked on several approaches, but finally decided on one design which appeared to be able to eliminate all four different cancer viruses including the one with the  $Y_g$  component equals zero. This new treatment was labelled BRC (80).

This special type cure, which we labeled BRC 80, continuing the line for BRC treatments.

Mix SP BRC80 CHL. These are the specs of each herb:

1.  $Q\ Y_n\text{-}Y_g$
2.  $Q\text{-}Y_n\ Y_g$

3. -Q
4. Q-Yn Yg
5. -Q
6. Q Yn-Yg
7. Q-Yn Yg

The procedure for this treatment, on the third patient on which we tried this new mixture (BRC80), indicated that for best results for eliminating all CVS present in any case of breast cancer, the dosage is two 900 mg capsules, twice a day, for 16 days and then we assess the condition of the patient. In our previous trials, there were three different cancers that were eliminated. The fourth CVS did not appear, even shortly after we finished the testing. This proved that the new treatment may be effective as a start for a course of treatment. It also revealed that there are at least three different CVS in the breast cancer situation, and not just one or two, but even three. This indicated that for the third patient, starting with BRC80, we may get good results. This is considering the fact that she already had breast cancer surgery previously, and her case is similar to cases treated many years ago.

These are the shadow energy characteristics of the new CVS causing the new cancer in the patient:

- Q=-25
- Yn=-30
- Yg=0
- Ω=-26

The following results indicate the day-to-day reduction in the shadow energies of the cancer, as the medicine is administered:

The results of the shadow energies of this new cancer show a gradual reduction of the energies until they disappear on the 17<sup>th</sup> day, 16 days after treatment began. Under thorough investigation, no new cancer shadow energies are detected. Even now, after many months of treatment, the patient is still cancer free. This proved that this new treatment will eliminate this new cancer, but does not prove that it eliminates any of the other three types. To prove that, other trials have to be made, with new patients, willing to try the VHM method of treatment, before having alternative types of treatment.

The concept that we can treat breast cancer, using VHM has been tried, not totally successfully, but it has proven that breast cancer may not be one single CVS, but could be up to four different types. They may be linked, or triggered one by the elimination of another, but there are at least four different types of breast cancer. This is a result which will aid any future research in the non- surgical treatment of breast cancer.

### Results

In our original manuscript, we concluded that breast cancer is basically a viral cancer, and as such, it may be treated by VHM. Several mixtures were designed and tried on several patients who had surgical mastectomies, in which cancer cells started to appear, months, and sometimes years after the operations. The VHM treatment were used successfully to eliminate these cells. Each one of these cases a different treatment was found to eliminate the cells. Sometimes, one treatment worked with another case, but not totally eliminating all the cells. This led to the conclusion that breast cancer is of viral origin and it may be treated without surgery.

New cases, without any surgery, revealed that there may be more than one type of cancer that appears after the first one is eliminated. Again, even a third and fourth types appeared. This indicated a multiple cancer that has three to four different cancers in it. Each needing a specific treatment, until we designed a new treatment to eliminate all four different cancers in one patient.

However, this was not tried in total, that is, on one person, until the disappearance of the cancer, it became unclear, that after all the treatments, one patient maybe totally cured without risk to the patient.

However, the results are clear, breast cancer is viral in origin, and we will, one day, have a cure without surgery.

### Conclusion

1. The results of these last few cases have reaffirmed our conclusion that breast cancer is viral in origin.
2. Because it is viral in origin, it appears to reappear, even after chemotherapy and radiation treatments, which may mean that there are more than one cancer virus in the ailment.
3. These latest cases indicated the presence of several different types of cancer complex virus systems, that needed different types of treatment to eliminate.
4. The initial type of cancer may not be the same in each case. Once the first one is eliminated, a second CVS cancer appears that needs a new treatment, other than the one that eliminated the first cancer.
5. In continuation in other cases, the third cancer appearing, may need a totally different treatment used for the second cancer, and may even be the same treatment used to treat the first cancer in the first case.
6. A fourth type appeared, slightly different shadow energy characteristics than the other three types, and needed a new treatment to eliminate it.
7. A universal vibrational herbal treatment was designed to eliminate all of the four different cancer types that appeared in all three cases. It appeared to work, theoretically, but we were not able to use it in an actual case study, as it might have jeopardized the health of the patient, if it did not work as designed. We did not determine in what sequence these cancers may appear, nor were we able to determine whether or not any new type would appear.
8. It is coming closer, that we will be able to eliminate breast cancer cases, without surgery, and eliminate the psychological and physical trauma of breast cancer [4-19].
