

The Treatment of Cancer of the Stomach Using Herbal Medicine

Abstract

When an important royal was diagnosed with an unidentified cancer, it became imperative to try to find out what type of cancer it is. Our experience in designing cures for cancer over the last twenty years, make it imperative to know where the cancer is, what causes it, how powerful it is, and how it may be eliminated. The first scrutiny indicated that the cancer is located in the stomach, that it is non-viral, powerful, but may be totally cured. Our traditional way of treatment, is by eliminating the shadow energies of the cancer, once they are identified. The slight digression is that it will need three different vibrational herbal mixtures (VHM) to effect the cure. Viral cancers, usually require one VHM mixture per cancer. This cancer is different, even though it is not a viral cancer, it will require three different VHM mixtures to eliminate all the shadow energies of the cancer. These are the "Q", "Yn", "Yg" and Ω components of the cancer. The cure is composed of two 1800 mg capsules of each one of the three mixtures, each mixture, to be taken after one meal daily, with no other medicines, a quarter of an hour before or after the VHM medicine. The duration of the treatment is thirty-three days of treatment, to be followed by X-ray weekly check-ups. The dosage may be increased if the need arises. This is based on the X-ray results and the physical condition of the patient.

Introduction

A word that invokes many emotions in a human being, so it was, when last week, his majesty king Charles III, after a routine prostate procedure, was pronounced to have cancer but not prostate cancer, and that he will be undergoing treatment almost immediately. There was no mention of the type of cancer except that it was not prostate cancer. To most cancer practitioners, it is quite disturbing. The causes of cancer can be very revealing, and in the case of his majesty, quite disturbing. We have studied several types of cancer, and the causes behind them and their treatment, and the first step is to diagnose the cause of the cancer, as that will determine how and what to do to stop the spread and to stop it, towards elimination. In modern scientific knowledge it may lead to other avenues of research, to determine causes, spread, effects and how it affects other organs.

In vibrational herbal medicine (VHM) procedure, it is imperative to identify the origin of the cancer, its type, how much has it spread and whether or not it is caused by a virus or some other type of cause. The cause will determine the method of treatment and whether or not progress will be made and the cancer will be eliminated. Our objective is to identify a method of treatment of stomach cancer.

Procedure

- 1. In our general procedure, we start by trying to discover the cause of the cancer and its whereabouts. This is accomplished by examining the whole body to discover any vibrational shadow energy of cancer being emitted in any specific area of the body. In all our previous trials we did exactly that. In our published manuscripts on breast cancer, Burkitt lymphoma, colon cancer etc. we determined what we believed to be the original cause of the cancer, then we carried on the procedure to ascertain if such was the actual cause, by eliminating the cancer shadow energy characteristics of the cancer in the patients. This is accomplished by using a simulation technique that does not affect the patient, but gives very accurate results on the condition, after the simulation test is made.
- 2. In this particular case, there is no mention of a particular position where the cancer is located. It is mentioned that it is not in the prostate. In our vibrational herbal medicine procedure, the search is instigated to determine the locality of the emergence of the cancer shadow energy, indicating where the origin of the emerging cancer may be. This will aid in determining the cause of the cancer and ultimately, how its treatment process will proceed.
- 3. There is an indication of the presence of cancer shadow energy within the abdomen of the patient, emanating from the stomach. Based on our previous records, this will be taken as the primary location, unless it is proven otherwise.
- 4. The following step is to determine what the cancer shadow energy characteristics are, and whether they are caused by a viral origin or other cause. This will determine the direction of the cure, if any.
- 5. The presence of the shadow energy characteristics is identified in the general area of the stomach of the patient. The following step is to determine the quantity, quality and power of this concentration of shadow energy, whether it is of viral origin or other non-specific origin.

The measured shadow energies of the patient, are as follows (Date 7th February 2024): Another reading of the shadow energies was taken on the 23rd of February, as check on the condition.

The shadow energies did not appear to be generated by any kind of virus, which makes it more difficult to try to eliminate. Viral origin cancers are usually determined by the volume, the power of the cancer, the size of the unit of the cancer block and the replication number of this particular cancer. This cancer is very powerful, and appears to be in the stomach. It does not appear to have spread outward, but appears to be still limited inside. From our study and observation of the cancer, it appears to be of unit 10 to the power 1800, that is each unit is sized as such and replicated by that volume. The number of replications indicates the size of the Cancer, our first estimate is 27,000,000 units.

6. Our initial estimate, based on our initial analysis, is that we may need 2 mixtures to complete the treatment of the cancer, as it is, in all probability a non-viral cancer. However, after several preliminary trials, two mixtures did not appear to be sufficient. In one instance, about 30% of the Q shadow energy still remained. In the second trial, the Yang shadow energy was still present at around 25% of its value.

- 7. We started to design three treatment mixtures, taking into consideration that all the shadow energies be eliminated by these three mixtures. Several trials were made and compared to the shadow energies of the cancer. The result was one mixture treatment for each of the shadow energies, that is one for the "Q" component, also eliminating part of the omega (Ω) component.
- 8. The second component was designed to eliminate the Yang (Yg) component of the shadow energies, and a part of the omega component.
- 9. The third mixture was designed to eliminate the "Yn" component and part remaining of the omega section.
- 10. After designing each one of the treatments, each for a component, it was tested against the actual cancer shadow energy of the patient. This was to check whether or not the shadow energies reacted with the treatment, and how much was the treatment effective, and what appeared to be the length and quantity of the treatment required to reach its goal of eliminating the shadow energy totally in the patient.
- 11. The initial results were quite promising. The treatments reacted well with the shadow energies and eliminated an appropriate portion of the shadow energy designated. It became clear that each treatment eliminated parts of the omega portion of the shadow energy; while all three eliminated all of the four shadow energies.
- 12. Having finished the design of all three mixtures, they appeared to work quite well eliminating the shadow energies of the cancer. Each treatment eliminated its allotted portion of the shadow energy. We tried to discover the result of using all of the treatments together and how well will they react with the shadow energies. This helped in determining the daily dosage of each of the treatments. The result of combining all three mixtures together, resulted in eliminating all of the shadow energies of the cancer, in addition to all of the portions of omega. This result indicated that the trial of the mixtures with the cancer is a success, and that we may be able to proceed to the second level.

Results and Discussion

Having decided on the parameters containing "Q" of the cancer, we started to design the components of the treatment to eliminate the shadow energies of "Q", by choosing each of the seven Herbs that are contained in the mi the shadow energy characteristics obtained for the patient have not been compared to any other cancer type.

In our search for a type and position of the cancer in the patient, our preliminary findings indicated that it may be in the stomach area. That is, it most probably is some kind of stomach cancer. The first test is to find the shadow energies of stomach cancer and compare them to our characteristics obtained from the patient.

The values of the shadow energies appear to be close and similar. We have now to compare with the actual treatments designed to see the effects of the treatment on each.

This accomplished by using the simulation method mentioned above.

The trial dosage of 1800 mg capsules of the treatment is placed by the specimen of the patient, on the biometer, to measure the resultant shadow energy and in how many days would it totally eliminate that shadow energy? The result was as follows:

• The patient: This is a simulation study to indicate the direction of the trial. This is made on the shadow energies obtained from the patient:

Q = 0, after 32 days of 1800 mg of daily treatment, after lunch, and discovered that there is a residual value of shadow Ω = -12, still active in the patient.

Adding the designed treatment for Yn, which is also 1800 mg of the Yn daily treatment, to the treatment of Q, we find that in 32 days, Yn = 0, while the value of Ω becomes = -4.

This value is down from -12. This indicates a positive development and that the shadow energies of the cancer are responding to the new treatment. The trial was continued by comparing the third component of the Yg characteristic, to the patient's specimen. The resultant values became $Q = Yn = Yg = \Omega = 0$, that is, all the shadow energy characteristics of the cancer specimen of the patient have become equal to zero, in other words, they are eliminated. This is one basic proof that the mixture treatments, of all shadow energies, are successful in eliminating the shadow energies of the cancer specimen. This is another indication that the cancer we are dealing with is stomach cancer.

• The specimen of the stomach cancer obtained, and how would that react to the treatment mixtures? We followed the same methodology as the actual cancer patient sample, to discover the reaction of the shadow characteristics on the specimen. We followed the same procedure used for the patient's specimen, to be as precise as possible. To check the Q component of the cancer specimen, the Q treatment is placed by the specimen and observe the resultant value of the shadow energies that were reached. "Q" value that was reached was = 0, after 32 days of treatment, two 1800 mg capsules after lunch daily. However, we reached a similar value for " Ω " = -4. The value is better than that reached for the patient's specimen. We continued the procedure, with the "Yn" treatment component, and then the "Yg" treatment components. The value of " Ω " finally went to zero, = 0, meaning that all the shadow energies of the cancer were eliminated.

Analysis

Having decided on the parameters containing "Q" of the cancer, we started to redesign the components of the treatment to eliminate the shadow energies of "Q", by choosing each of the seven herbs that are contained in the mixture.

The design parameters of the "Q" of the treatment. Each group indicates an herb specification:

- 1. Q -Yn Yg
- 2. Q Yn-Yg
- 3. -Q
- 4. Q -Yn Yg
- 5. Q Yn-Yg
- 6. Q -Yn Yg
- 7. Q Yn Yg.

This design is the best that was obtained at the moment, to eliminate most of the shadow energy of the cancer, although it will be reexamined again after all the mixtures are designed. The second mixture to design was that of the Yn shadow energy. The same parameters employed in the design of the Q shadow energy was used for the Yn component. We tried several trials components, to try to find one that increases the value of the Yn component, and reduce the time needed for the elimination of its energy characteristics.

The second designed treatment mixture appeared to be as follows, this is to determine the Yn component of the treatment:

- 1. Q Yn -Yg
- 2. Q -Yn Yg
- 3. -Q
- 4. -Q
- 5. Q Yn -Yg
- 6. Q Yn Yg
- 7. Q Yn -Yg.

Although symbols are used to identify the required herbs, the herbs have already been chosen to obtain the best results for the mixture.

Having designed the Yn component, it was time to work on the third component, the Yg component, which was designed as follows:

- 1. Q Yn -Yg
- 2. Q-Yn Yg
- 3. -Q
- 4. Q Yn -Yg
- 5. Q-Yn Yg
- 6. Q Yn -Yg
- 7. Q Yn Yg.

This third mixture component is the third component needed to totally eliminate all of the shadow energies due to the cancer discovered. The next step is to check the ability of this new treatment to affect the cancer in our patient. The method is simple; if the shadow energies are affected by these treatments, and a decrease of such energies occurs in the patient, then this is a positive indication that the cancer is affected and has been reduced. How much reduction, and how much is the dosage, frequency and length of treatment.

Results

Cancer patient I

The interesting feature is that this treatment has three different mixtures, while there appears no evidence of the presence of any complex virus systems causing the cancer. Usually, in viral cancer cases in (VHM), the cancer is identified by a complex virus system, and a treatment is designed, usually having one treatment mixture to eliminate all the shadow energies of that cancer. In this case, no virus is identified and there are three treatment mixtures that are needed for treatment. We propose to test each mixture totally on the subject and then add the second, to observe the result, and then add the third mixture and observe the resultant reaction. The first results are due to the introduction of the mixture to eliminate the shadow energy due to "Q". Then we add that to eliminate shadow energy of "Yn" and check the results. Then add the treatment mixture to eliminate the shadow energy due to "Yg". The results show that the relevant shadow energies are eliminated by the introduction of the corresponding shadow mixture.

When the three are combined the total amount of shadow energy is eliminated and the cancer is totally eliminated. This accomplished using a dosage of 1800 mg for each mixture, each taken after one meal daily, for 33 days of treatment.

Cancer specimen

The same procedure is followed with the cancer specimen of stomach cancer, as a control specimen, to check and compare results. The same procedure is followed, first we add the "Q" component, then the "Yn" component, to see the effect of both, and then add the third "Yg" component. The results are as follows:

The cancer specimen reacted similarly to the patient specimen. This indicates a high probability that the patient has stomach cancer and is to be treated as such. There are slight differences between the specimen of the patient and that of the stomach cancer specimen, but the results change in the same direction until they become zero, after the term of treatment of 33 days, at a dosage of 1800 mg of each of the three different mixtures, daily. The patient recorded no shadow energies from the four components, and neither did the cancer specimen. This indicates to us, that the three mixtures constitute the cure for stomach cancer. Further to actual clinical trials, this may be the available treatment of actually destroying the stomach cancer. This may entail slight changes in the amount of treatment based on which type of stomach cancer we are dealing with.

Our latest check on the patient (R), are as follows, based on our shadow energies analogy:

The first reaction is that whatever treatment is being administered, it has not taken much effect in the four shadow energies whatsoever, in a short 14 days of treatment. Hopefully, there will be some improvements, as treatment progresses. From initial results, however, it does not appear to be working.

Conclusion:

- 1. Stomach cancer is not one of the viral caused cancers.
- 2. Our understanding of viral caused cancers is that they are treated as would one treat a virus. Determine the structure, the power of the virus, size, types if any, and then design a cure that eliminates all of the shadow energies of the cancer and stop its spread. Usually, it is one treatment per virus, but non-viral origin cancers, we had not been able to proceed.
- 3. In this case of stomach cancer, we discovered that more than one treatment mixtures are required. A treatment for each of the three main components of the shadow energies of the cancer, i.e. one for "Q", one for "Yn" and one for "Yg".
- 4. The shadow energy Ω , did not require a separate mixture, but it was being eliminated gradually by the main three mixtures of the components. This may have given us a way into treatment of non-viral based cancer treatments.
- 5. The dosage is that of 1800 mg/per mixture, given daily, after a meal, for the duration of 33 days of treatment.
- 6. Our initial premise, is that the patient being treated, and the side objective of this manuscript, has stomach cancer, which may be totally curable under these circumstances.
- 7. Our initial reaction to whatever treatment is being administered, as it has been publicized, does not seem to have been effective; based on our parameters [1-10].
