## Treatment of Breast Cancer with Vibrational Herbal Medicine

#### **Abstract**

Breast Cancer is a nightmare for many women. Its presence invokes images of pain, fear and mutilation.

This study is about finding the cause for breast cancer and identifying ways of treating it and eliminating the risk to patients. We have discovered that breast cancer is caused by a very powerful virus, and is composed of three genotypes, ranging from weak to powerful. They are all quite pervasive. We have identified some Vibrational Herbal Mixtures (VHM) that will eliminate the tumors in about 40 days. We have discovered that once a cancer vibration is discovered, this is not an easy task, tumors appear usually after six weeks and the cycle begins. Tumors can be eliminated using VHM, but the advice of Surgeons is to remove the tumor immediately and may not agree to try the VHM. Even if mastectomy is performed, VHM is recommended to eliminate any recurrence of the Cancer.

### Introduction

Breast Cancer is described as Breast cancer is a type of cancer that starts in the breast. Cancer starts when cells begin to grow out of control.

Breast cancer cells usually form a tumor that can often be seen on an x-ray or felt as a lump. Breast cancer occurs almost entirely in women, but men can get breast cancer, too.

It's important to understand that most breast lumps are benign and not cancer (malignant). Non-cancerous breast tumors are abnormal growths, but they do not spread outside of the breast. They are not life threatening, but some types of benign breast lumps can increase a woman's risk of getting breast cancer. Any breast lump or change needs to be checked by a health care professional to determine if it is benign or malignant (cancer) and if it might affect your future cancer risk" [1-25].

This disease is a woman's nightmare; it entails a complete change in the life of the patient and a great deal of psychological trauma.

This was witnessed first- hand, when a close friend of the family was diagnosed with breast cancer and her attending surgeon instructed her to immediately have a mastectomy otherwise her life would be in jeopardy. This person was totally destroyed after her operation and never recuperated from the trauma of that experience.

At that time, I had been working with a new healing technique that I discovered several years before. This technique is called Vibrational Herbal Medicine (VHM). The main theme, which was used by the Ancient Egyptians and the Ancient Chinese, was based on the fact that the healing qualities in Herbal Medicine depended mainly on the vibrational properties of the herbs and their mixtures and not on their physical or chemical properties.

For many years before that time, I had been working diligently to find a Vibrational Herbal cure for Hepatitis C Viral and was engaged in various experiments to try new approaches and concepts to apply to Vibrational Herbal Medicine (VHM). A few years earlier, I started to experiment on HIV, to find a treatment and a cure.

By sheer coincidence, a friend of the family had been operated on and had her breasts removed, in the mistaken misconception that that will eliminate the cause of Breast Cancer. However, several months later, the cancer appeared again.

She approached me to find a cure for her condition. The cancer had now spread to the lymph nodes and was spreading slowly all over her body.

#### Diagnosis of the patient's condition

- a- This was the first case of Breast Cancer presented to me for study. We had to determine all the parameters of the ailment. In our case, we determined the energy characteristics of the organs affected, what are the other energies emanating from the tumor, and how are the energy groups of the patient that are affected.
- b- The patient had had a mastectomy several months previously and started feeling some additional lumps appearing in various parts of her body. She had completed a full chemotherapy protocol under the auspices of a prominent oncologist. She had been assured that the cancer had been totally eliminated. She had to undergo checkups every six months after that as a precaution to check any tumors appearing.
- c- Our preliminary check indicated that cancer had spread from the primary location in the breast, outwards, into the lymph nodes. The probability was there that it was the same type of cancer and can be eliminated using some type of chemotherapy. The patient was placed on Chemotherapy for three consecutive rounds. Although they reduced the levels of infection, they did not eliminate or diminish the infection. Our preliminary investigations revealed that some of the herbal mixtures may help, they would be reducing the energy groups controlling the disease; but may not totally eliminate the energy groups that cause the tumor. Another approach had to be taken. The assumption was changed to assume that the tumor is caused by a virus. We started to measure the parameters that control the presence of the cancer. All results of the study of the tumor reflected the strong presence of a viral entity causing the tumor. Several VHM mixtures were made to react and eliminate the energy groups emanating from the tumor. There was significant evidence that the mixtures eliminated parts of the energy groups. This had to be proven by allowing the patient to take one of the most effective mixtures to test. Theoretically, the mixtures reacted well with the patient and no adverse side effects were detected in the theoretical trials. The patient was given a four week dosage of the treatment, two 900mg capsules to be taken after lunch. Instructions were to monitor the patient for any discomfort or any adverse side effects, such as hyper-acidity. However, none of these side effects were reported by the patient. Our daily checks on the condition of the patient, indicated an improvement in the condition of the patient, as a reduction in the energy groups. The first results of the blood tests of the patient, after the completion of the treatment course, was a reduction of about fifteen percent in the tumor markers from the previous tests. The patient was elated.

It appeared that the cancer is viral based. It became necessary to describe the characteristics of the virus to be able to design a cure. After completing the check up, our conclusion was that the cancer was caused by a virus.

#### Treatment of the cancer

We started working in determining the size of the virus, its power and energy characteristics. The first Vibrational herbal mixture (VHM) made for this patient helped slightly and reduced the cancer markers slightly. What interested us was the fact that the treatment had an effect, although small, but it had an effect. That meant that we were on the right track. That the effect of the treatment was small indicated that we had to increase the power of the treatment and increase the scope of its effect. It is easy to write about it now, more than ten years after the fact, since these issues plagued our research in finding any cure for any virus for a long time, until they were resolved.

This patient took three different Vibrational Herbal Mixtures (VHM), consecutively, and they improved her condition and reduced the cancer markers but did not eliminate the cancer. This was the mastesized cancer of the breast. We were under the impression that it would not respond well with the breast cancer cures, as it may have changed in some manner from the original strain.

However, our Vibrational Herbal mixture was based on the assumption that the virus was the breast cancer virus and not a different type of cancer. This patient finished three consecutive courses of treatment, although the VHM reduced the cancer markers significantly, the MD supervising the case did not believe that the results were because of the VHM taken by his patient. He decided to continue with a new chemotherapy treatment that was received from Japan and suggested that it will have excellent results. However, that was not the case, and the patient did not react well to the new treatment. This was the time of political upheaval in Egypt and we lost touch with the patient. Regrettably, the patient passed away six months later, as we heard. It is important to note that this patient's condition indicated seven tumors on the liver. After our three interventions, we had eliminated three of the tumors and with a marked reduction in the cancer markers

Several months later, another patient approached us to try our Vibrational Herbal Medicine (VHM). The limited success we had in combating VHC produced a great deal of good will, as treatments went. This patient was diagnosed with breast Cancer and her attending surgeon insisted that she perform the mastectomy soonest otherwise the tumor would spread rapidly and would be unstoppable. At that time, we had an effective VHM treatment, based on several experiments, and it was designed to eliminate the cancer in about between 45 to 55 daily doses of 1800 mg capsules, once a day, for the duration. However, we could not advise the patient to postpone her operation and try the treatment for at least 45 days to try the mixture. Her surgeon was adamant that she perform the operation within 48 hours or suffer the consequences. We did not make any follow through calls and do not know what the outcome of that operation was.

In the next two years, we had several consultations from breast cancer patients. These consultations helped us in improving the VHM treatments as there appeared to be three distinct levels of the virus. These varied in the size and thus intensity of the infection. This is indicated in the appendix 1.

This may have helped in our conclusions in the presence of three different levels of Breast Cancer. This translated as slow spread, medium spread and the rapid spread cancer. This can be attributed to the size and power the virus. This is shown in appendix 1. However, the final main treatment was designed to totally eliminate whatever type of breast cancer virus, in the shortest possible time. We are working to improve and reduce the time frame of the treatment.

The daughter of a friend was diagnosed with breast cancer and was living overseas. I diagnosed her condition as the medium spread type, i.e. the medium powered cancer. The treatment was prepared to take for 45 days, as she had to travel and would be out of reach. The daughter was operated on before the medicine reached her. Her Doctor decided that no medicine has been discovered yet to cure cancer of the breast and went ahead. My examination of the patient indicated that about 15% of the virus was still active in her body, although the cancer tumors were totally scraped. In my opinion, and based on my experience with viral cancers, if the virus is not totally eliminated, it will appear within a period of 12 to 18 months. My advice to my friend was to ask his daughter to take the VHM and make sure that the virus is totally eliminated. This was confirmed to me after eight weeks that she had taken the treatment. I could not find any percentage of the virus in her body, even today, eight years after her operation.

#### **Conclusion**

- a- We are certain that Breast Cancer is caused by a virus.
- b- That there are three types of Breast Cancer, our experiments have revealed that the virus is composed as follows:

- 1. 900 million units of 10 to the power of 1710 MCVs (Major complex virus systems)
- 2. 810 million units of 10 to the power of 1710 MCVs (Major complex virus systems).
- 3. 720 million units of 10 to the power of 1710MCVs (Major complex virus systems).

All types are possibly curable by VHM. The only obstacle is the urgency attributed to each condition by surgeons.

- c- In our opinion, it is advisable to take the VHM, even after a mastectomy, to eliminate the chances of the cancer returning.
- d- It is advisable for women to undergo regular check- ups, especially if they are prone to having Breast Cancer in the family.
- e- The presence of Breast Cancer energies indicates an imminent threat of tumors appearing within four to six weeks of its detection.


