The lives and health of children in conflict and war zones

Reports from UNICEF stated that greater than 300,000 grave violations were carried out against children in conflict and war affected regions between 2005 and 2022 [1]. In addition, not less than 120,000 children were killed or maimed during C-W around the globe across continents in the same period, reflecting an average of almost 20 children daily [1]. At least 105,000 children were recruited or used by either armed groups, or the formal armed forces [1]. There were more than 32,500 abducted children, and 16,000 were subjected to sexual abuse [1]. The stated violations were committed in greater than 30 conflict zones across Asia, Africa, Latin America, and the Middle East [1]. The UN also verified more than 16,000 cases of attacks on hospitals and schools, and greater 22,000 instances of renunciation of humanitarian access for children [1]. The true toll was described to be likely to be far higher, as the reports were only for the verified cases. The reports illustrate the devastating impact of C-W on children. In order to proffer solutions, UNICEF co-organized a conference with other intergovernmental, governmental, and non-governmental organizations. UNICEF then made specific commitments to consolidate her initial commitment to the protection of children in conflicts and wars [1].

Children caught in conflict- and war- (C-W) afflicted zones constitute a vulnerable population that deserve special attention for protection and healthcare. As man-made disasters continue to ravage humanity across the globe, children have been made victims of avoidable and often unyielding conflicts and wars, which are always ignited by adults. History has never told us of C-W sparked by children, we only always hear of children as victims of those outrages. Children are the reflections of any community, and they can only glow where and when there is peace. The health and lives of children caught up in the crossfires in *zones on fire* require responsible *parents* in every society, to protect children from the ill effects of man-made disasters. *Parents* are not only the biological entities, as every right-thinking adult in every society does not need to be tutored that children are the responsibilities of all adults. With the available *media platforms* in the contemporary *jet age*, it is almost impossible to hide anything happening under the sky. Information, news and data from C-W areas all over the world do not speak well of the trauma being inflicted on children when C-W break out. Children being brutalized, beaten, raped, maimed, starved, recruited as soldiers, killed *etc* are a few of the unforgivable atrocities that adults commit against children. Abuses against children should not have been imagined, let alone executed by any right-minded adult of any breed. Children are exposed to unheard and unseen injuries in their bodies and minds when C-W occur. In addition, they undoubtedly experience neglect, hunger, disease, bullying, or one form of slavery-like condition or the other. Therefore, it is pertinent that local, national, and international authorities keep the welfare of children in mind, and reflected in their actions when conflicts and war break out anywhere around the world.

Whose fault?

Parents, as expected become helpless when C-W occur, and children are mostly left to fend for themselves. The perpetrators of any form of abuse or trauma against a child are directly to be blamed, while the initiators of C-W are the major players in the deprivation of the rights of children. Abuse of children through the infliction of physical or psychological injury on them may undoubtedly be described as a crime against humanity. Children should be spared of any form of injury in times of C-W anywhere in the world. The societies which have neglected children to cater for themselves in periods of chaos should not be excluded when the blame arises. Thus, organizations should deem it fit to consider the protection of the health and lives of children a key priority in places where conflicts and war are ravaging. Community leaders and governments should not hesitate to take up the duty of protecting children in those tense circumstances, otherwise their hands may be soiled with the bloods of innocent children.

Whose gain?

Conflicts and wars become the motives of adults in the course of the race for power, wealth, political affluence, or rivalry. So, why should children be the *sacrificial lambs*? There is no gain for the cognitively upright people in dehumanizing children under any circumstance. On the other hand, it appears more of an intentional act of hurting the *enemy* by traumatizing their children. The predators believe they are making gains by making children pay the price. It is actually no gain for anyone, but a loss to humanity that children are not only left unprotected but injured physically or psychologically during C-W due to faults that are not theirs.

To conclude, as human rights of children are usually overturned in times of wars and conflicts, it is vital that all relevant stakeholders give special attention to the health and lives of children in order to protect them from the atrocities that they are at risk of during periods of mayhem. The rays of reflections from the mirrors of the wellbeing of children within the zones of crossfires continue to fade away when children's health and lives are left to chance due to the neglect and abuse that they experience. To ensure that humanity is giving its right belonging, children should be protected *against all odds*, and be given a right to life not only in times of peace, but also in periods of conflicts and wars.
