

# The Treatment of Memory Loss Due to the Advent of Alzheimer's

#### **Abstract**

Memory is a vital function in the history of humans. Once it starts to fade, much of a human beings' accomplishments, do not seem real nor his existence appears worthwhile. The person loses touch of his surroundings, friends, relatives and most importantly their whole existence. The advent of Alzheimer's' disease does that to a person. Our endeavor to try to ameliorate the effects of Alzheimer in two ways, one to eliminate the cause of the disease which we have discovered to be viral in origin, and two, to enhance the shadow energies in the brain controlling memory, to stimulate the memory banks and bring life back to a forgotten past.

Our task became clear, if we could design a memory enhancer, to increase the value of the shadow energies controlling memory, and make sure it actually enhances the shadow energies controlling memory, then we can affect a tremendous change in the condition of many Alzheimer patients, throughout the world. - 4. -Q

- 7. -Q

The above notations are those of the herbs that used, without mentioning each one by name. This mixture was mixed and capsules made for trial on the patients. In this case, it was the 70 years old, Professor of Urology in one of the Egyptian Universities, he had already taken our Alzheimer treatment, which is intended to eliminate the virus causing the disease. The best (Theoretical) results obtained after 15 days of 1800 mg daily dosage of the memory enhancement mixture were as follows:

- Q = 70
- Yn = 69
- Yg = 72
- Ω = 25.

The values are remarkable, and there were no side effects indicated, we made the capsules and presented them to the patient, to start a clinical trial. He started taking them right away, and we kept close watch over the results.

The patient was quite impressed with the results as he remembered all of the prayers used during his morning prayers, and he was not at loss for words any more during his clinical hours, no embarrassment with any of his patients anymore. Another patient was prescribed the memory treatment; however, her condition is much more advanced than the other patient.
