

The Treatment of HIV Using Vibrational Herbal Medicine Part II

Abstract

This is the second part of the manuscript about treatment of HIV. This takes into account our findings over the last few years, that autoimmune diseases, are actually comprised of a "cluster", containing several CVS'S, that are the cause of the disease. In order to effectively eliminate that disease, each one of these CVS'S have to be eliminated. The CVS'S are activated, randomly, as we believe now, but the sequence determines the symptoms portrayed by the disease. The activation of CVS#1, may manifest a variety of symptoms that may or may not, resemble our previous understanding of the disease. HIV was originally considered (from our studies), to be composed of three main CVS'S, all our studies until just a few years ago indicated that. Once we discovered the presence of clusters, containing a number of CVS'S, determining the symptoms and the disease, we looked into the possibility that HIV is a cluster based disease. It is now added to several "cluster" based diseases, such as diabetes, breast cancer, bone cancer, lupus, psoriasis and many others. A cure is obtained by eliminating all existing CVS'S in a cluster and not before. Many of the previous treatments have been able to eliminate one, two or three CVS'S, from the cluster, but not all. We now have a cure to eliminate all the CVS'S of the cluster and the disease itself.

Introduction

The first part of this manuscript dealt with the discovery of what HIV has been described in the literature of the late twentieth century and early twenty first century. From the first day of studying HIV, by measuring the shadow energies of its components, or in any afflicted person, we were intrigued by the fact that the shadow energies indicated two positive and two negative energies. This is totally alien to the studies of the previous years indicating that any virus is determined by four negative shadow energies: negative CHI (Q), negative YIN (YN), a negative YANG (YG), and a negative Omega (Ω). What became more intriguing to me, was in the shadow energies study of diabetes, the same phenomenon appeared again, two positive and two negative shadow energies described diabetes and anyone who suffered the condition. Granted the shadow forces were not similar, but it raised serious questions, as whether HIV could be similar to diabetes, or could one use the medication of one to treat the other? Actually, we did. We used some medication made for diabetics, to theoretically, check on some HIV patients, our methods allowed that, without giving the medication. It did not yield any tangible results. We tried the other route, some HIV medication on diabetic patients, (theoretically), still no tangible results. Our conclusion was that they may have similar shadow energies, they did not share the same disease.

Our continuous studies on HIV indicated that there are three different CVS, that used to appear together, in the same virus conglomeration. We were able to identify each one with its shadow energies, and designed mixtures to eliminate each one of them. However, originally, we thought that, although they are HIV viruses, they were different types. We had two famous models to study, the British patient, who apparently was "cured", but was discovered sometime later, that the infection did not disappear. Although the scientists were reputable scientists, we were amazed that they indicated the patient was cured, when in fact we still detected approximately 13% (at that time), of the HIV virus was still active. Our tests on the British patient indicated that he was still an active HIV agent, and was not totally cured. This apparent confusion in the results indicated to us that we have to resolve this complexity. We believed our conclusions were correct, and that the British patient was not totally cured. The explanation of his team was that he was re-infected somehow, and they started on that premise. Our conclusion was slightly different. We had discovered three different viruses in some of the HIV patients, what if the HIV virus actually contains all three viruses? In order to eliminate the HIV virus, all the three different viruses in the group had to be destroyed to affect a complete cure. The second HIV patient who was well known was the Mississippi baby. His mother had HIV carrying him, but did not have HIV when born. Again, our investigations revealed that he was not totally cured, but had 13% of the HIV virus still active in him (her). That reinforced the idea that these patients have not really been totally cured, but they still had one or more CVS'S still active.

Procedure

Around that period of time, some statements were being floated that the HIV virus is an autoimmune disease. It also was being stated that diabetes is an autoimmune disease. These statements, reminded us of the period in which we were studying the energies of HIV and diabetes, that both had two negative and two positive shadow energies. Although they did not affect the same disease, they were different. We had determined that all viruses had four negative shadow energies, while HIV and diabetes, had each two positive and two negatives, and they were labeled as autoimmune diseases. What if the characteristics of autoimmune diseases, is an indication of a way to clearly define what an auto immune disease is, and what a virus is?

In this respect, we already established that a "virus" contains four negative shadow energies, and that became a constant. Each CVS was designated with four negative shadow energies. Each CVS we identified, indicated that characteristic. The results were quite impressive, and led to many viable treatments for various different ailments. This finally culminated in the publication of mentioned in (I-a) above.

Thinking along the same lines, we decided to study in depth, the concept of shadow energies in "autoimmune diseases" as described by the nomenclature of the era. In our own research, we discovered that HIV and diabetes had two positive and two negative shadow energies. Studying each one of these ailments separately, we discovered some more CVS, in both diseases. After a long period of study, it became apparent that the designation of an autoimmune disease, does not mean what it describes. Our conclusion is that it only means that there are more than one CVS causing this disease. This was published as Almoez Le Din Ellah MS Eltouny, "Autoimmune Diseases as Characterized by Vibrational Herbal Medicine". EC Clinical and Medical Case Reports [6].

The discovery that an autoimmune disease is a viral grouping of CVSs, that may or may not be active simultaneously, but probably in a specific sequence depending on the type of individual or the type of where the infection took place. That is, what is the sequence of this group's activation blueprint? That was one of the reasons that autoimmune diseases were difficult to diagnose and treat. Once this concept was proven to be correct, we tried to find treatments for such autoimmune diseases. We tried to identify how many CVS's appeared in each case of that disease and which of such CVS's are active and which are dormant? This is not such an easy endeavor. It became easier using the vibrational concept of viruses. To try and identify the shadow energy characteristics of each of these groups containing the CVS's causing such a disease. Some of these diseases are mentioned in the autoimmune disease manuscript mentioned above, but later on, it became evident that that is part of the story.

In a separate study, we started to write a manuscript on the treatment of diabetes. Diabetes was mentioned in the mentioned manuscript, on autoimmune diseases; however, the more we delved into the studies, the more we discovered more CVS'S then we had

been discovered previously. There are specific sequences to such CVS's becoming active, and that determined what type of diabetes would finally emerge. We discovered that there are six types of diabetes, not just two. The well-known phenomenon of a pre-diabetic condition, is actually diabetes having already started to take hold, having two CVS'S becoming active, but not beyond the level designated as a diabetic condition. It also became clear that type I diabetes, as known to medical science, is a specific sequence of these CVS'S, activated in a constant manner, the same for each diabetic patient. Type II diabetes, has a different sequence, with other sequences determining other types, which change as more CVS'S become active and causing the six types we mentioned. The most important consideration in this case, for the type II patient, is to stop the deterioration of the condition, into becoming Insulin dependent and move into a type I category. We devised a treatment, to do just that. Type I is more of a problem, which we are pursuing, to maintain the level of medication and to prevent deterioration of the condition of the type I patient into more severe diabetic condition.

It appeared that the recurring theme is the appearance of whatever virus, or ailment, even after it is declared cured. This is not an isolated incident in one or two ailments, but it became quite apparent in several cancer cases that we had investigated over the last 30 or so years. One of the most common cases, is the reemergence of breast cancer after thorough and comprehensive treatment. Whether it is a mastectomy or plain removal of a tumor, plus a few lymph nodes, for safety reasons, the cancer appears somewhere else, in the lymph nodes, the bones or the liver to mention a few places. As an outside observer, I was totally perplexed that our great Medical Scientists, with their huge research funds and big labs, are not able to totally eliminate such a menace, nor even give a reasonable prediction as to why that was happening.

Observations

Although our primary objective in our study of vibrational herbal medicine (VHM), was to discover a viable treatment for hepatitis C viral, as a close friend of mine was afflicted in the late 1989. He was being given the best treatment in Europe, but there were no actual cures at that time. Dr. Khalil Messiha, an MD and an Egyptologist, introduced me to the study of medical practices in Ancient Egypt. Dr. Ibrahim Karim, a well- known Architect, and a former schoolmate of mine, had a workshop teaching the study of energy and the usage of Ancient Egyptian Pendulums. To me, it was a fascinating topic which appeared to strike an inner passion in me. My concern was my afflicted friend, whom I thought that maybe some an ancient remedy that might be able to help him, whilst current medical science could barely touch the unknown causes of that ailment. I explained the problem to Dr. Khalil, who became quite enthusiastic in helping as proof of the healing qualities of ancient science. We tried two of his creations, to control and destroy hepatitis C viral; regrettably, they did not make any dent in my friend's condition, as he was deteriorating slowly, with no cure in sight. After several months, there did not appear a viable cure in any horizon.

Maybe, it was my time to try something. I was not totally convinced that any of the methods used as a cure, made logical sense to me. I decided to study the hepatitis C virus, using the specimens of the patients, to try to figure out, what exactly is the virus? How does it work, is it alive and what triggers it? I tried to determine the elements of the virus, what energies did it have, and was it alive; what changes could happen to it, and if so, could they be measured? The process took a couple of years to answer some of these questions, and gave me answers to questions that lead me to check on what was being called the "Ancient Laws of Wisdom". It seemed like a jig saw puzzle that is being fit into its place. This culminated in the first Manuscript, labelled "The Ancient Laws of Wisdom and Vibrational Herbal Medicine". Published in 2001, by "Explore Publications", out of Prescott, Arizona.

Unbeknownst to me, this became the blue print of most of my work for the next twenty- five years, with minor modifications, additions and new revelations, in the following years. My friend died after a short time afterwards, but his legacy prompted me to work on an Herbal cure for many ailments, one of which is hepatitis C viral, other ailments and many types of cancers.

Over the following years, the process of obtaining a treatment for hepatitis C viral went well, and made many modifications on the treatments, but the main obstacle, in my research was the relationship among the different genotypes of the hepatitis C virus. A patient

comes to me, complaining that his tests indicated hepatitis C viral, but which type? There are six types of hepatitis C viral, they do not necessarily indicate severity of the condition, because parameters of the ailment were not totally known. Is type VI, different from type IV, and in what way? For a long time of misconception, and due to the lack of understanding of the disease, it became an iron clad statement, that most Egyptian patients suffered from type IV hepatitis C, which is supposedly, the most vicious of the types. In a few years, my conclusion was that that was not a true statement, I had studied and treated hundreds of Egyptian patients, all across the land-scape, from the North to the southern most part of Egypt, and less than 20% had a similar hepatitis C virus, which was compatible with a few herbal treatments, but did not react with others. Others needed several other types of treatments, that did not necessarily coincide with one another. We measured the number of CVS'S in each type, we could not definitely ascertain which type is which. In our mind, there has to be order in the hierarchy of the virus, and we looked for that, but for more than 14 years, that eluded us. In the meantime, eight patients, in different parts of Egypt, were totally cured of the virus, using our Vibrational Herbal Medicine.

Over the same period of time, between 1995 and 2014, we were engaged in treating other ailments that eluded the grasp of medical medicine, or the understanding of some physicians. We will only mention one type which is relevant to our manuscript here. Several cases of breast cancer patients wanted some kind of remedy after the reappearance of cancer, after removal of breast cancer, which in many cases meant mastectomy. The lumps appeared in different places, not necessarily in the breast. Breast cancer, was an enigma, and a terror for any woman, at whatever age. The outcome is usually as bad as the results with or without treatments (Without is worse). Our thoughts were why is it that an ailment (Breast cancer), appears after being operated on and totally cleaned up? (As is alleged)! Our most preliminary investigation indicated the definite presence of a virus. You cannot eliminate a virus by an operation. The only thing that will reappear, is either a virus or a bacterium, if it is not totally eliminated. Thus, our primary objective is to prove or disprove the primary cause of breast cancer, irrespective of any other effects that it may have on the patient. Three cases presented themselves for treatment. The first was the daughter of a friend of mine, who lived abroad was diagnosed with breast cancer, and promptly had a mastectomy, before I could recommend checking. However, my advice, after checking her, was to actually take my treatment for breast cancer, to eliminate that specific virus that still remained in her body and was not eliminated. My friend trusted my judgement and sent her the anti-viral treatment, to complete the treatment. Now, although it has been about 12 years, she never developed any cancer recurrence. However, to be fair, she was very lucky! Now, I know that she had a type I breast cancer, with two CVS'S, one was eliminated by Chemo, after surgery, and the second, was eliminated accidently, by my mixture. However, she made it until now.

The second case, the patient had a mastectomy, with chemo and some radiation, but started to have small lumps develop in her breast and close to the lymph nodes. Our examination showed that there is still a presence of a virus, in the virus. However, it did not respond to any of the several treatments I had, at the time, for breast cancer. I had to design one treatment to fit this particular virus. This patient was a physician in a university hospital, and was being treated there, but she wanted to try my treatment. She started taking the herbal mixture, and after close to 18 days, her tumor markers went down considerably. That was quite reassuring to her and to me. She was taking a new chemo therapy injections from Japan, and we thought that they had a hand in this. However, my energy analysis revealed that it did not react at all with the tumors, and in all probability, it was my treatment that helped. That reinforced my belief in the theory of a viral disease. The reduction of tumor markers heartened her, but again, a new negative energy appeared, indicating a new virus in the group. I started working on a cure for the new virus, but at that time in 2011-2012, the political situation in Egypt, was not inducive to transportation, visitations or treatment. There were curfews, political unrest and inability to communicate. I lost contact with my patient at that time. However, there was further proof that there was more than one virus involved in breast Cancer. The question became how many CVS's, how many types, what sequence, if any, and were the viruses the same in each patient? Questions that needed more time and many more patients, and a great deal of Luck.

The following years, our research lead us into different paths, but the thought: why cancers recur? Was always on my mind. We were involved for the following two or three years in fully exploring the treatment of hepatitis C viral and all its genotypes. Several other

ailments occupied us briefly, now and then, and several discoveries on various ailments were reached. Most discoveries were not in the direct concepts of medical science approach, but the results were phenomenal. Just to cite a few; the treatment of Parkinson's disease, Alzheimer's, MS, hepatitis C viral, and made very powerful head way in the treatment of HIV, which is the reason for this manuscript. Many of the findings made over the years culminated in a better understanding of how some ailments work and therefore how they can be treated.

The study, by accident, of Burkitt lymphoma, lead to a better understanding of treating, and will ultimately lead to curing it. It is not as difficult as some may assume. The manuscript published in 2021 on Burkitt lymphoma, is an introduction to the definite Cure. Almoez Ledin Ellah MS Eltouny. "Treatment of Burkitt Lymphoma with Vibrational Herbal Medicine". The reference is made to different ailments, all of them are viral based. We mentioned specifically breast cancer, as it has always intrigued me and why cancer usually reappears after treatment. This has been the case in other viral ailments such as HIV and the case of the British patient. While other ailments did not remerge after treatment, there appeared to be a different configuration between the two. While an ailment such as Parkinson's disease (PD), once fully treated did not reappear, while HIV when appeared to have been cured, showed an emergence baffling the scientists.

After studying several cases of breast cancer, a new concept seemed to emerge. That each viral cancer type comes in groups, each group may be different in all cases, or sometimes similar, but this group we labeled a "Cluster", containing a number of CVS'S, that become active, in a specific manner for each patient, not necessarily in the same sequence of activation, depending on the number of CVS'S and type of the CVS'S, meaning triple negative types in type I breast cancer. This is explained in our manuscript # 20 Almoez Ledin Ellah MS Eltouny. "Breast Cancer: Using Vibrational Herbal Medicine: A third Consideration". Ecronicon open Access. Published on October 21, 2024.

In a different manuscript, "treatment of bone cancer using vibrational herbal medicine", we realized that cancer comes in groups. The number of CVS'S in the group, determine its inclination and, sometimes, its severity. They do, however, tend to follow the same rules in sequencing of activation of CVS'S, for each type of cancer. This did not end there, our manuscript on "autoimmune diseases", and their treatment clearly indicated the presence of groups, containing the various CVS'S within the disease. However, our discovery was only limited to what we were able to determine, at that time of the number of the CVS'S within the group containing the disease. It became imperative in order to reach a cure, to eliminate all of the CVS'S in that group. The presence of these "groups" containing the CVS'S, led us, to the beginning of naming these groups, informally, as clusters.

Procedure

We started looking into a cure for HIV, many years ago, around 1997 and 1998. This was some time after we started looking into a cure for hepatitis C viral. Very little was known on this new disease which was labeled HIV. It was surmised that it was a virus, but no definite proof was reached at that time. As an exercise, in addition to my work in hepatitis C, I tried to figure out what is HIV, with whatever knowledge that was available at that time. I could not find specimens to study, only photographs of some patients of HIV, which were very few and far between. I could not find any description or photo of the diseased specimens. The only other recourse was to study the energy of the patients afflicted with the disease, to find out what there was, especially the shadow energy of such people and, if possible, the shadow energy of the disease itself.

From our work on hepatitis C, the patients always manifested four negative Shadow Energies: The Liver, the main object of the study, even though we were studying the virus responsible for that disease. The following Shadow energies were present in each one of the patients studied: -Q, -Yn, -Yg and an - Ω . Which were consistent in every patient of Hep. C viral. Always, four negative shadow energies. However, in the case of HIV patients, this became different. There were always two positive and two negative shadow energies for each

patient. It seemed like something was off here, we knew that hepatitis C is caused by a virus, and it gave four negative shadow energies, what in the world was this new configuration: two positive, and two negative shadow energies? How did this figure out in our investigative reality?

What became more intriguing, was the fact that studying diabetic patients, trying to understand and find a viable treatment for diabetes, we discovered that its patients also exhibited this phenomenon of having two positive and two negative shadow energies. Is HIV and diabetes one and the same? Or are they just similar somehow? But they are not; so why this similarity?

HIV is a disease, not any different in its objective; to perpetuate its existence, in the process, to harm or even kill the patient. Our objective; is to destroy that disease. In our initial research on HIV, we believed that it is a virus, probably similar to other viruses. Over the course of our studies, we discovered a few shadow energies in each patient which indicated the presence of CVS'S. We believed, originally that they were the same virus; as we were not able, at that time to differentiate among the shadow energies tabulated. We tried to design treatments to eliminate each shadow energy from each subject. We tried the different mixtures on the different subjects, trying to discover if it reacted with any of the patients, and by what percentage did it react with each? The mixtures reacted in different ways. Sometimes they eliminated a small part of the shadow energy, sometimes a larger part, we were still unable to find one treatment that eliminates each of the group of shadow energies that appeared, but we were getting closer.

In order to eliminate this scourge of a disease, we have to eliminate all of its multiple CVS'S, as we have discovered at least three different CVS'S in each one of the HIV patients studied. It appears there are three different CVS's, comprising the group we recognized as causing HIV. We designed hundreds of treatments for each one of the CVS'S discovered, trying to eliminate the CVS under study. This took a great deal of time, because we had not been able to determine the structure of such CVS'S, or the relationships among the CVS'S. We were trying to eliminate a virus which is basically an unknown quality, and we had to assume its power, size, strength and how to eliminate it, in the shortest possible time. That, took a great deal of time, effort and ingenuity. Many trial mixtures were designed, made and tested, that was per each CVS discovered. We did not know if they were similar, as we only had shadow energies for each patient, at different stages of development of the disease. Not relying on our own work, we tried these mixtures on the well-known patients of the time, such as the Berlin patient, and the Mississippi Baby. They worked some, and (theoretically) eliminated parts of the CVS'S in these patients, but some did not react at all! This was performed, over the years, for each one of the CVS's discovered, one by one, until we designed a cure for all main three CVS'S that we deemed to be contained in the HIV group. Some examples of the treatments that were made, and eliminated all of the shadow energies of the CVS'S, discovered until that time.

These mixtures were designed after discovery of different CVS'S within the same patient with HIV. These were checked by using to see whether or not it was compatible with elimination of the Shadow energies of HIV in patients.

We continued our work, however; we were studying other ailments; depending on whatever cases that were brought to our attention. HIV cases, after discovering the three CVS'S in the group of autoimmune disease, we turned our attention to other diseases. We were looking into MS, Parkinson's (PD), some cases of Alzheimer's, and any disease we thought that we may be able to contribute in finding a cure for. In many cases, some minor discoveries opened the way for a different outlook into the treatment of a disease, which moved us closer to a better understanding of the disease, and also to a better treatment. Time phases coalesced together, trials meshed together, at least in our minds, distinctions among various diseases became less distinct, as we began to see a bigger picture in which many diseases would fall in.

It may have been the concept of autoimmune diseases and how we interpreted it, as a grouping of different CVSs, that actually determined the basic concept of a disease we were looking for. Our continued search for the reason cancers recurred, specifically breast cancer, pressed us on, to find the answers to these questions. Why?

After discovering the concept of clusters, a new design had to be made to eliminate all types of CVS'S in that cluster. This concept of a cluster became apparent in our study of breast cancer, in colon cancer, and in cervical cancer. Whenever a CVS was identified and eliminated, another CVS seemed to appear out of nowhere and continue its elimination of live tissue. We have now come to the realization that the reason some cancers recur, is because of the fact that they come in clusters. Each cluster contains several types of CVS'S, depending on the type and power of the cancer.

The treatment mixture for the HIV cluster

The discovery of the concept of clusters and its confirmation in various manuscripts, has led us to re-examine the treatment of HIV. HIV, has been designated as an autoimmune disease. We have written about it in our manuscript on autoimmune diseases, but now it becomes imperative to re-examine the treatment of HIV, not as an autoimmune disease only, but as a disease which may be "Cluster" based, which may make it easier, using our technique to design a cure for the cluster- based ailment, which may be more than only three CVS'S in the group.

We have been studying what we believed HIV is, for more than twenty-five years. We made several discoveries along the way, and made deductions on what that particular disease is. It appeared to befuddle scientists studying it. It was virus based, it attacked the immune system of patients, it is unstoppable, it is proclaimed a death sentence to whomever was infected by it. We studied it from a different perspective, we wanted a cure, not just to prolong the life of the patient, but to cure the patient; and eliminate that stigma from humanity. We are looking for a cure!

We searched for patients, who were extremely difficult to identify, due to they way some countries treated them. They are a different, flawed group of people, who, for some fault, many times, not their own, became infected. Do we help them or stigmatize them? Humanity, went into several phases during the 1980's, 1990's and in the early part of the twenty first Century. My interest was peaked to the challenge that it is an incurable disease. No such a thing! God created it, He must have a plan! It is a challenge added to Humanity's many challenges; how is Humanity going to react? It does not have to be all of Humanity, just a small group, who believe in the infinite Wisdom of God, that a cure is there, find it. With it, increase your vast Knowledge of diseases and cures. Work towards a better humanity and better people.

We have discovered the concept of clusters, it works with breast cancer, bone cancer, psoriasis, lupus, diabetes, to name some diseases, why not HIV. We have a long history, studying and treating HIV patients; what do they tell us now, about HIV? I found two specimens of HIV patients treated early in 2000's. They are both alive, and reasonably well, both are on the HIV medication to slow the disease, but not to eliminate it. If I may, for the sake of Ethical practices, think that the pharmaceutical companies could not make a cure! I may presume that they did not have the knowledge, or may be the way?

Patient one: Male, a Frenchman, around 25 years old then. Started treating him, by sending the relevant mixture to him in France. After all this time, about 15 years, I was quite surprised to see that we both are alive; because of my age and because of his illness. I started to examine him, by reading the shadow energies of the HIV virus present. It had declined by some degree, but the HIV was still there. In the last check, about six years ago, I had discovered 3 active CVS'S in his body. They were still there. Using the new cluster theory approach, I discovered nine different CVS'S in his body. I have now been able to "see" six more CVS'S that were unseen by me six years ago. Two of the CVS'S were about 40% eliminated, due to my previous medication sent to him, many years ago. This is quite a feat! What about the other patients? The shadow energies of this patient, several years ago were:

There is a marked change in the cluster of HIV shadow energies. I discovered that two CVS'S are eliminated totally, with three more that are affected and three that are active. As there is no evidence that a new cure for HIV has been announced, the current treatments to slow the progress of HIV, may be responsible for the elimination of parts of the CVS'S in the HIV cluster. Our medication may have contributed to some of the elimination, but which ones, we are not certain. The main factor is that some of the CVS'S are eliminated.

Patient two: He was a friend of a colleague of mine, a male 42 years old then, living in France. My friend found out that this friend was suffering from HIV. He knew of my work, as I was treating a relative of his from viral hepatitis C, and he was getting better, so why not try the HIV treatment that I have designed? I sent him three different medications, over a period of around 12 months. I could only send the medication with someone, and not by Courrier, after 9/11, and after the upheaval in 2011 in Egypt. It became impossible to send any medicine by mail. I started checking the shadow energies of the HIV virus, to check on the status of the patient. It had been close to ten years, since the last medication. The startling discovery is the presence of nine CVS'S in a cluster, causing HIV. However, three of these CVS's, had about 35% of its shadow energies eliminated. A very powerful message that the treatments I sent have been quite effective, as it eliminated parts of an ailment science, as far as I knew, couldn't eliminate parts of. The results so far, indicate the presence of a "cluster", containing nine CVS'S that may be responsible for the heinous disease. The current check indicates that three CVSs are eliminated, two others are affected, one active and three still inactive.

He is definitely much older, but his condition is stable, the shadow energies have been switched around, this is due to the fact that changes have occurred in the CVS'S that are eliminated. It appears that three CVS are totally eliminated and others have various components eliminated which may explain the changes in the shadow energy matrix of the patient, over time. The patient is alive and

doing well considering, but is still suffering from HIV, his energy level has improved but he still has HIV. There are still several HIV CVS'S still in the HIV cluster, and is still HIV positive. The total cluster containing the HIV CVS'S is composed of nine CVS's. Five are currently active, in different modes of activation, parts of which are eliminated, while four CVS'S are dormant; and none are totally eliminated.

As predicted, two positive and two negative shadow energies. We checked which of the mixtures that we had, or if we didn't have a mixture, we made one to fit and eliminate the shadow energies present. We gave him two consecutive treatments, but our liaison was no longer available, and we lost touch. The patient is a till alive; the shadow energies show an improvement to his previous condition. This may be attributed to the medication I sent and probably the medication being taken to slow the progression of HIV. However, the indication that he is taking some medication to slow progression, is not evident. The cluster theory is new, and has been found in dealing with various diseases, and appears to be quite viable. Is it the same for the latest versions of HIV or maybe it has changed into something else? However, from the current findings, the components of the HIV cluster appear not to have changed over time.

It has been five years and I decided to check up on her condition, after such a long time. The new readings confirmed my first assessment that she actually suffers from HIV, but her condition improved since my first check. It is interesting to note that I met with her again, after her brief visit to Norway, when she informed me that she did not have HIV. She declined to take any medication from me. At that time my second assessment remained the same; she was afflicted with HIV. I did not comment, it was her decision. The following are the shadow energies of the Norwegian girl, then and now:

Her condition today is kind of remarkable, compared to some other patients. She appears to have four CVS'S eliminated, very interesting, three CVS'S that are dormant, one active, and one just alive. The shadow energies, from my perspective, appear to be moving towards

the shadow energies of a virus. This may mean that she may be taking some effective life prolonging drugs, or maybe a new drug that eliminates certain CVS'S, but taken as a life prolonging medication. As a check, we used our new treatment to eliminate all nine CVS'S on her (theoretically), and it eliminated all the shadow energies; Q, Yn, Yg, and Ω all equal zero. That is to say, to us she is moving towards eliminating the components of the HIV cluster.

New HIV patients

There are several new patients that have been identified. Many celebrities seem to advertise having HIV, not try to shy from declaring it. A great step for mankind?! We tried the older versions of the cure, based on the assumption that HIV contains 3 different CVS'S. The results are indicated on the right of the page. The mixture used is Mix HIV 492. Three CVSs were eliminated only.

This a is a Hollywood figure, well known, but our interest lies in the type of viruses, in the system. The system shows nine CVS'S in the HIV cluster. The shadow energies also indicate the HIV trade mark of having two positive and two negative shadow energies. Our test is the reaction to our medication, for one two, or three CVS'S that we had designed several years back. They also are eliminated by the latest designed mixture, the cure which is written down below.

The sixth patient: This is a patient who is also a Hollywood Celebrity, but not totally famous, but suffering from HIV.

The shadow energies also indicate the telltale of HIV or (Autoimmune) disease. The older medications eliminate from two to four CVS'S, but the cure eliminated all nine in twenty days and 1800 mg, of the mixture, daily. This the closest test that we can make. Theoretical, yes, but 99.99% accurate from previous experimentation. The true test, is an actual clinical trial on patients in various stages of the disease, to determine its powers and limitations and boundaries. We tried, earlier, before the cluster phase, through the offices of WHO, informally, but we were met by great skepticism by the patients, that may have bordered on aggressiveness. We wanted them to try the herbal medicines, to help them be cured, and it was for free. They were quite skeptical, and wanted to be paid to take the medicine. They were being given free life prolonging HIV inhibitors (I suspect) by WHO, and they have been brainwashed that this is an incurable disease, so what am I attempting to rob these people by trying on them a dubious medication that will definitely make a lot of money for me, off people's souls. So, they want their share. Regrettably, I did not have a sponsor and was self-financing. The WHO could not help, and I did not want to jeopardize the position of the person trying to help.

Results

- 1. Our insistence that HIV is a virus, albeit, an autoimmune disease, was actually explained by the cluster theory.
- Our discovery that many viral ailments are designed in clusters of CVS'S that cause the disease, and must be all eliminated to affect a cure, has allowed us to design cures for several ailments and several so-called autoimmune diseases.
- 3. Applying the cluster theory on HIV, fit perfectly, and we discovered in each patient, a cluster of nine CVS'S, that have to be eliminated totally to reach a cure.
- 4. The appearance of HIV in any patient, is dependent on the activation of one of the nine CSV'S, originally, and followed, over time by others, to determine the deterioration of the condition of each patient.
- 5. Each one of these CVS's affects and acts on a specific area in the patient. These paths may be determined by further studies of each individual cases and the Knowledge of each CVS that is active.
- 6. We are not certain on the exact sequence of activation of the CVS'S, and how they influence the progression of the disease.
- 7. The terminal point at which it becomes futile to medicate, is still to be determined, although we are sure of the high effectiveness of the cure.
- 8. There is hope for all HIV patients, soon enough.

Conclusion

- 1. HIV has been designated as an autoimmune disease.
