Strengths:

- 2. **Focus on originality and interdisciplinary:** Encouraging innovative and cross-disciplinary work is in tune with the modern research landscape where complex problems require integrated approaches.
- 3. **Mission for rapid publication:** Timely publication is a significant need in both clinical and scientific research, particularly in fast-evolving fields like paediatrics.
- 4. **Accessibility and readability:** Emphasizing user-friendly language and structure improves the real-world impact of published work, especially in applied sciences and clinical domains.

Areas for clarification or enhancement

- Quality control: While rapid dissemination is valuable, it must not come at the cost of rigorous peer review. More clarity around peer review policies, editorial board structure, and quality assurance mechanisms would strengthen trust in the journal's integrity.
- **Statement refinement:** Some parts of the mission (e.g. "to get to know, to discover, to publish") are vague and could benefit from clearer articulation. Stronger, more specific phrasing would improve professionalism and reader confidence.

• **Scientific impact:** The mission could include a clearer emphasis on measurable outcomes such as indexing, impact factors, and citation standards, which are important for authors choosing a publication venue.
